The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 10/28/2021, at approximately 0317 hours, the affiant was traveling eastbound on Brandon Blvd when I observed a silver Ford F-150 directly in front of me in the inside lane. The affiant observed the F-150 swerve into the middle lane and overcorrected to the left causing the truck to leave the roadway. Based off my observations, I conducted a traffic stop on the vehicle to check on the well being of the driver to see if they were ill, tired, or impaired. Upon contact with the defendant, I observed him to have bloodshot watery eyes and the distinct odor of an alcoholic beverage emitting from his breath. The defendant was asked to perform Standardized Field Sobriety Exercises which he agreed. During the exercises the defendant showed signs of impairment and was placed under arrest for DUI. The defendant agreed to provide two lawful samples of his breath, which resulted in a BrAC of .103/.099. The defendant was positively identified via his FL DL.
