The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was operating a silver 2017 Jeep Grand Cherokee, 4 door SUV, Florida tag QDDG54. The defendant was involved in a three vehicle traffic crash, in which he was determined to have been driving at night without head lights on, causing a white 2013 Nissan Altima, 4 door, Florida tag Z440NX, to enter the roadway into the defendant's path due to not having seen the vehicle approaching. The Nissan was struck in the side by the defendant's vehicle, which spun clockwise and struck the front passenger bumper of a brown 2017 Kia Forte, 4 door, Florida tag KMDK26, which was stopped at a stop sign. The Nissan Altima sustained an estimated \$7,000.00 in damage, while the Kia Forte sustained an estimated \$1000.00 damage. The rear female passenger of the Nissan Altima was transported to a hospital with non-life threatening injuries, and her 4 month old child was taken to the hospital for observation purposes. TPD Officers who responded to the crash scene noted signs of impairment with the defendant, and located a witness who positively identified the defendant as being the driver of the vehicle at the time of the crash. Video surveillance footage was also obtained which showed the defendant exiting the driver side of the vehicle after the crash. The defendant sustained an airbag burn to the inside right forearm, consistent with that of holding the vehicle steering wheel at the time of airbag deployment. I responded to the scene as a DUI Investigator. The defendant was advised that the civil traffic crash investigation was complete and a DUI investigation was being conducted. The defendant was advised of his Miranda Rights. The defendant stated he was driving, and was not injured. The defendant stated that he had consumed three White Claw alcoholic beverages before the NFL football game this afternoon. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed and he swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and had difficulty following simple instructions. Based on a totality of the circumstances, the defendant was arrested for DUI. The defendant refused to submit to a lawful test of his breath for the purposes of determining its alcohol content after being advised of the Implied Consent Warnings. The defendant was positively identified by his Florida DL.
