The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 23 day of NOVEMBER, 2019,

at approximately 3:10 AM, at 2494 13TH AVE N. APT 108, in Pinellas County did:

DID THEN AND THERE ENGAGE IN SUCH CONDUCT AS TO CONSTITUTE DISORDERLY CONDUCT, TO-WIT: THE ARRESTED WAS AGGRESSIVELY PULLING ON DOOR HANDLES IN HIS APARTMENT COMPLEX SWEARING AND YELLING AT OCCUPANTS INSIDE A NEIGHBORING APARTMENT UNIT TO OPEN THEIR FRONT DOOR SO HE COULD GAIN ENTRY, WHICH CONSTITUTED A BREACH OF THE PEACE.

THE ARRESTED WAS OBSERVED AGGRESSIVELY PULLING ON THE DOOR HANDLE OF APARTMENT # 108 WHEN THE ARRESTED LIVES IN APARTMENT #308. THE ARRESTED WAS SHOUTING AT THE OCCUPANTS INSIDE OF APARTMENT #108 TO "OPEN THE DOOR" AND "DON'T FUCKING MAKE ME DO THIS". THE ARRESTED CONTINUED TO POUND HIS FISTS ON THE THE DOOR OF UNIT #108 AND WAS COVERING THE PEEP HOLE TO PREVENT THE OCCUPANTS FROM LOOKING OUT. THE ARRESTED WAS PREVIOUSLY ADVISED BY THE POLICE 30 MINS PRIOR TO HIS ARREST TO MOVE ALONG FROM THE PROPERTY DUE TO THE ARRESTED BEING LOCKED OUT OF HIS OWN APARTMENT #308, BUT THE ARRESTED REFUSED VACATE THE AREA AND HE CONTINUED TO ATTEMPT TO GAIN ENTRY INTO ANY OTHER UNIT POSSIBLE.

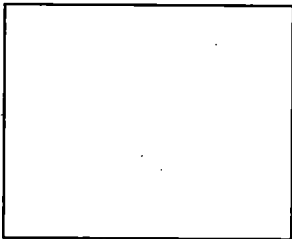
