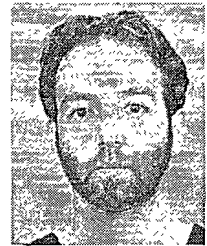

PROBABLE CAUSE AFFIDAVIT

Before me this date personally appeared, Detective Nicole Freeley who being first duly sworn
deposes and says that on 24 day of Februrary, 2017 at 1130 SE 4th Ave, #B, Fort Lauderdale, FL (crme location) the
above named defendant committed the above offenses (s) charged and the facts showing probable cause to believe same are as follows

This affiant is part of a National Task Force, South Florida Internet Crimes Against Children (I.C.A.C.), that investigates internet crimes against children, child pornography and other related offenses.

On February 7, 2017 this affiant initiated an investigation into the distribution of child pornography on the Edonkey Peer-To-Peer file sharing network. This affiant located an IP address 98.203.121.165, accessing the network and offering to share child pornography videos and images between January 19, 2017 through February 21, 2016. A total of 65 child pornography files were observed during this time period. The video images found contained very young children under the age of 12 engaging in various sex acts with and without adults and children.

The IP address was registered to Comcast Internet Services and a subpoena was issued for the account holder and associated information for the subscriber using IP address 98.203.121.165, at the time the mentioned files were noted on the suspected computer. Comcast Internet provided the following information:

PROBABLE CAUSE AFFIDAVIT

Before me this date personally appeared, Detective Nicole Freeley who being first duly sworn
deposes and sane that on 24 day of February, 2017 at 1130 SE 4th Ave, Fort Lauderdale, FL 33316 (crime location) the

above named defendant committed the above offenses (s) charged and the facts showing probable cause to believe same are as follows

A search warrant for the above residence was obtained on February 23, 2017 and signed by the Honorable Judge Lisa Porter in Broward County, Florida.

At approximately 6:00 am, on February 24, 2017, the search warrant was served at the above listed address and contact was made with resident Tsuru Manor, who was advised of the situation. Manor was the only occupant of the residence. Manor advised he been residing at the residence for the past 1 months. Manor stated that he installed file sharing programs on his Desktop computer. I read Manor his Miranda rights and he stated that he understood and was willing to talk to me without an attorney present. Manor stated that he had files download from the file sharing program to an external hard drive which is located in the closet in his bedroom. When Manor was asked if any child pornography would be found on the computer by the forensic examiner he stated, "Yes". He stated that the child pornography was videos with young females between the ages of 12-13 years old engaging in sexual acts with children and adults. Manor stated that he was the only person that lives in the residence and uses the computer.

The on scene preliminary forensic examination of the external hard drive yielded evidence of child pornography. The videos were located on the E drive which is an external hard drive. These videos depicted female children between ages of 10 to 13 years old engaging in sexual acts such as oral sex, masturbation, lewd display of genitals and digital penetration. A total of 10 videos were located on the external hard drive during the preview.

Manor was taken into custody and transported to BSO Main Jail for booking.
