The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 9/09/21, at approximately 1150 hours, at 1527 High Knoll Drive the defendant did unlawfully push the the victim with his hands during a domestic argument.
