On 01/25/2021 at approximately 1833 hours, I responded to the front of 1300 NW 7th Ave (Kwik Stop) in reference to an assault.

Upon arrival, I made contact with W/M James Williams, who stated that he was just assaulted by another male, and he pointed to the white male, who later self-identified and was confirmed as Tyler Mulvehill. Williams advised the following: On 01/25/2021 at approximately 1830 hours, Williams was a customer of Kwik Stop and had been listening to a discussion between a group of people outside of the store. The group of people were talking with a woman, who was no longer on scene, about politics. Williams then began talking with the woman to try and calm her down, and the woman was leaving the store in her vehicle. Williams continued to talk with the woman when all of a sudden, Mulvehill thrust himself in front of Williams and was telling Williams to "get out of her face." Williams then faced Mulvehill and lifted his left hand up in front of his face, but did not throw his hand towards Mulvehill. Williams intention was not to hurt or punch Mulvehill, just to tell Mulvehill that he was not in the female's face. That is when Mulvehill then kicked Williams in Williams' groin area. Williams fell backwards as a result of Mulvehill kicking him. Upon asking Williams if he needed any medical attention, Williams stated he did not. I observed a dirt mark on Williams' pants that is consistent with him being kicked in that region. Ofc Maranges obtained a sworn victim statement from Williams. See his MVR body camera for further details.

I then made contact with Mulvehill separate from Williams. Mulvehill advised that he observed a group of people talking about politics, to include a woman that was no longer on scene. The woman then decided to leave the store in her vehicle, and as she was reversing her vehicle from the parking spot, Williams was following beside the vehicle and continued to talk with the woman. Mulvehill then approached Williams and told him to

<p>leave the woman alone. Williams then raised his hand up in the shape of a fist and was spitting at Mulvehill, telling him to mind his own business. Mulvehill then struck Williams in the groin area with his foot as, what he claims, an act of self-defense. After Mulvehill kicked Williams, the woman left the scene in her vehicle, and Williams called the police.</p> <p>I then made contact with one of the witnesses on scene, W/M Calvin Valero. Valero advised that he was a customer at the Kwik Stop. A group of people, including the woman who was no longer on scene, himself, and Williams, were all having a civil conversation about politics. The woman, at one point, told Mulvehill to mind his own business because everyone outside was having a civil conversation. The woman then decided to leave the Kwik Stop because she felt as though Mulvehill was agitating people. As the woman was leaving in her vehicle, she had called Williams over to talk with her by her vehicle about politics. Mulvehill then approached Williams by the woman's vehicle, and Williams then told Mulvehill to mind his own business. Out of nowhere, Mulvehill then struck Williams in his groin area with his foot, which caused Williams to flip over onto his back. No one was arguing with the woman. Mulvehill was told multiple times to mind his own business by the woman and Williams. Valero did not see Williams raise his hand up at or towards Mulvehill. Ofc Maranges obtained a sworn witness statement from Valero. See his MVR body camera for further details.</p> <p>I then made contact with the store manager, W/M Bakir Shehadeh. Shehadeh advised that when he was walking outside of the store, he observed Mulvehill strike Williams with his foot. He did not observe Williams physically touch Mulvehill. Ofc Careccia obtained a sworn witness statement from Shehadeh with his full testimony. See his MVR body camera for further details.</p> <p>Shehadeh advised that video surveillance of outside by the front of the store captured the incident. I then reviewed the video surveillance. In the video surveillance, I observe a white female appearing to have a conversation with a group of people outside the front of the store. She then gets into her vehicle and begins to reverse her vehicle. Williams is walking beside her vehicle talking with her and motioning with his hands downwards as if telling her to calm down. The female stops her vehicle, and Mulvehill gets out of his own vehicle that is parked out front of the store. Mulvehill then walks up to Williams. Williams turns and faces Mulvehill and lifted his left hand up but does not throw his hand toward Mulvehill in any threatening manner. I did not observe Williams get into any fighting position. Immediately, Mulvehill then strikes Williams with force in the groin area with his left foot, causing Williams to fall backwards.</p> <p>Due to the fact that 1) all parties involved: two independent witnesses (Shehadeh and Valero), the victim (Williams), and the suspect (Mulvehill) stated that Mulvehill kicked Williams, 2) video surveillance clearly showed Mulvehill approach Williams while</p>

Williams was talking with the woman in her vehicle, and then forcefully kicked Williams in the groin area, causing Williams to fall backwards, and 3) Williams is over the age of 65 years, I have determined that Tyler Mulvehill is in violation of F.S.S. 784.08(2c) Battery on Person 65 Years or Older. Mulvehill was then placed under arrest and handcuffed, double-locked and checked for proper fit. He was then placed into my marked police vehicle. Mulvehill was later TOT CJ without incident.
