**Probable Cause**

On November 25, 2020, at approximately 2:38 am, Recruit Trooper K. Depeine # 4782 and I, were traveling north on Interstate 95 (SR 9) from the Woolbright Rd on ramp. While merging on the interstate, I observed a white in color Dodge pickup traveling at a high rate of speed, passing us in the inside center lane. I then instructed Recruit Trooper Depeine to over take the vehicle and conduct a

pace clock.

While pace clocking, I observed the vehicle weave in its lane and then veer to the right into the center lane. The vehicle continued to weave, failing to maintain in its lane. The vehicle was paced clocked at 100 mph in a 65-mph zone. The vehicle then switched into the center lane and then to the outside lane. The vehicle then veered off the roadway to the right into the right shoulder and then back into the outside lane. The vehicle was traveling in an unsafe manner while passing other vehicles. Based on these observations, I instructed Recruit Trooper Depeine to conduct a traffic stop using the patrol car emergency equipment. The vehicle was a white Dodge pick up with Kansas tag R004565.

The vehicle then stopped on the right shoulder just south of Forest Hill Blvd. Recruit Trooper Depeine and I then made a passenger side approach and made contact with the Driver. The Driver was identified as Valaine Marie Vitale Renner, via her Florida driver's license. Immediately I observed an unknown odor of an alcoholic beverage coming from inside the vehicle. I also observed Ms. Vitale to have blood shot water eyes and appeared to be lethargic. I then asked Ms. Vitale if she had consumed any alcoholic beverage and she stated she had "two shots" of fireball.

Based on my observations, I believed to be under the influence of alcohol while driving. I then asked her if she was willing to perform field sobriety exercise's and she consented. Due to the area of the traffic stop, there was not enough space and not safe to conduct the exercises. I advised Ms. Vitale that she would be taken off the interstate to conduct the exercises. She was then transported off the interstate to the 7 Eleven located on Forest Hill Blvd. While on the way, I observed a strong unknown odor of an alcoholic beverage inside the patrol car that was not present prior to Ms. Vitale. Once at the 7 Eleven parking lot. Ms. Vitale performed poorly on the field sobriety exercises.

Ms. Vitale was then advised she was under arrest for driving under the influence of alcohol and placed in the back of the patrol car. She was then transported to the Palm Beach County Jail. While on the way to the jail, I again observed a strong unknown odor of an alcoholic beverage. Once at the jail, I conducted a 20-minute observation. During this time, Ms. Vitale did not eat nor regurgitate anything. After the 20-minute observation, Ms. Vitale was then asked to provide two breath samples and she consented. The first breath sample was of .265 and the second of .255.

Ms. Vitale was then charged with driving under the influence of alcohol and issued a citation for failure to maintain lane and unlawful speed. She was then released to the jail for further booking.

All events occurred in Palm Beach County.

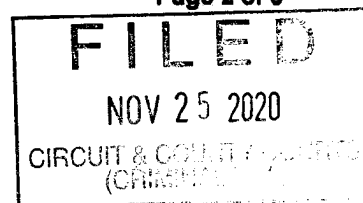
