On March 12, 2022 at approximately 1:40 AM while on routine patrol in my marked patrol vehicle southbound on Florida's Turnpike (State Road 91) I observed a red Nissan Rogue bearing a Florida tag GEAL02 weaving within the outside travel lane near the Lake Worth Service Plaza. I activated my in-car camera to observe a driving pattern. While driving south, the driver of the red Nissan continued to weave within his lane, break checked twice, and straddled the center and outside travel lanes four times. The driver's speeds varied from 58 mph to 70 mph in a posted 65 mph zone. After observing an unsteady driving pattern, while other drivers were on the highway, I decided to conduct a welfare check on the driver. I looked for a safe location to conduct a traffic stop southbound on Florida's Turnpike south of Mile Marker 85.5. The driver pulled to the right shoulder.

As I approached the passenger side window of the vehicle, I observed a Hispanic male (later identified by his Florida's driver's license C-140-860-75-343-1 as Valentin Cabal) in the driver's seat. I identified myself and asked Mr. Cabal for his driver's license. I then advised that I pull him over for straddling the travel lanes and weaving within his travel lane. I then asked him if everything is ok, he stated "yes I was talking to my wife on the phone." I asked him if he was talking on the phone, or texting? He stated, "he was texting." Although I did not observe Mr. Cabal texting, I advised him that it is illegal to text and drive. I asked him if his address on his driver's license was current and he stated "yes." I asked him where he was headed to, he stated "home." I asked him where he was coming from, he stated "Coral Springs." I asked him if he knew what county he was in, and he did not know. I observed Mr. Cabal eyes to be glassy and bloodshot. HIs speech was slurred and mumbled. I asked Mr. Cabal to shut the engine off of his vehicle and asked where the key fob was located. Mr. Cabal reached into his front right pant pocket, pulled out the key fob and handed it to me.

Trooper Romaine Clarke ID # arrived on scene, spoke with Mr. Cabal and advised me that he detected an odor of an alcoholic beverage emitting from his breath. I asked Mr. Cabal if he would conduct Standardized Field Sobriety Tasks (SFST) to see if he was ok to drive. He stated "yes." As Mr. Cabal exited his vehicle, he stumbled and swayed to the right. I patted down Mr. Cabal for safety, placed him in

After the defendants 20-minute observation, the defendant was then given the opportunity to provide a sample of his breath which he consented and provided. The defendants first breath was given at 3:25 AM and resulted in a 0.231. The defendants second breath was given at 3:28 AM which resulted in a 0,215.
