The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 4-29-2020, at approximately 0502 hours, at the Wawa located at 15524 Dale Mabry Hwy. N. Tampa, FL 33618, the defendant and victim were engaged in a verbal argument in the parking lot. The victim walked inside the Wawa to purchase an item and was standing at the customer service desk. The defendant approached the victim and the two of them continued to verbally argue.
