The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 04/01/2021, at approximately 0314 hours, I was conducting stationary traffic enforcement and sitting on the west side of N Dale Mabry Hwy. I observed a blue Nissan Rogue, bearing Florida tag GRTS20, to be traveling south on N Dale Mabry Hwy. Using my HCSO issued radar unit, I measured the speed of the Nissan Rogue to be 61 MPH in a posted 45 MPH speed zone. I conducted a traffic stop on this vehicle at the intersection at N Dale Mabry Hwy and Hudson Lane. Upon contact with the defendant, I observed her to have glassy eyes and the distinct odor of an alcoholic beverage emitted from her breath as she spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which she agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI. The defendant then provided a lawful sample of her breath, resulting in a BrAC of .121/.119. The defendant was positively identified via her temporary Florida driver's license.
