Upon making contact with the defendant, she displayed multiple indicators of impairment, including: slurred speech, a strong odor of an alcoholic beverage on her breath, fumbling fingers, difficulty giving her attention, she urinated on herself, he was swaying and unsteady on her feet, admission to drinking alcoholic beverages, and had difficulty following simple instructions. The defendant performed poorly on the SFSEs and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .174/.169. The defendant was identified via her FL driver's license.
