While on patrol in the city of Fort Lauderdale in my fully marked FLPD police vehicle I responded to Bull Market at the listed location in reference to a disturbance in progress. Upon arrival I made contact with DEF (Vanessa Caruso) ID by FL DL. DEF was yelling and screaming in public disturbing the quiet and peace of onlookers who had begun to gather to observe the disturbance being caused by DEF. Probable Cause Affidavit

Before me this date personally appeared DUNN, ANDREW R. (1934) who being first duly sworn deposes and says that on 1 day of May, (year) 2017 at 210 SW 2ND ST. FORT LAUDERDALE, FL 33301 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

general disruption of the buisness and interrupting thier business. DEF was placed under arrest for disorderly conduct. DEF was placed in the back of my patrol car. Ofc. C Campbell and Ofc. Mick arrived on scene. Ofc. Campbell took a position neext to my police vehicle so that he could observe her while in the rear of my patrol vehicle. Ofc. Campbell advised that he observed DEF inside the vehicle loose from the handcuffs that I had placed on her. Ofc. Campbell advised that upon opening the door, DEF struck Ofc. Campbell in the face with her fist (see suppl Ofc. Campbell). DEF was again placed into handcuffs and back in the rear of my patrol vehicle. Ofc. Mick then attempted to speak with DEF. DEF spit projectile saliva onto Ofc. Mick (see supplement). DEF was transported to FLPD Jail where a spit mask was applied due to her constantly spitting within my patrol vehicle. DEF was then transported to BSO Mail Jail for processing.

In addition to the charge of disorderly conduct, Caruso was charged with two counts of resisting without for slipping out of the handcuffs twice. Caruso was also charged with Battery Leo for striking Ofc. Campbell and for spitting on Ofc. Mick.
