## PERSONAL CONTACT

### DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On the aforementioned date and time, I was conducting routine patrols in the area of S.R. 706 (W Indiantown Rd.) and C.R. 809 (Military Trl.) in the Town of Jupiter, Palm Beach County, FL. At the time, I was driving an unmarked Jupiter Police Department patrol vehicle (vehicle 1916), I was wearing a JPD uniform clearly identifying myself as a Jupiter Police Officer, and I was wearing my department-issued Axon body camera. I observed a gold 2002 Toyota SUV bearing FL tag # KNXB35 traveling westbound on S.R. 706, in the inside lane, just west of the aforementioned intersection. I observed the vehicle was weaving heavily within and outside of its lane. The vehicle continued westbound on S.R. 706 and weaved over the dashed lane divider separating the inside lane from the center lane several times, by approximately one-half the vehicle's width (but not quite). The vehicle also weaved over the solid white lane divider separating the inside and center lanes of westbound S.R. 706 near the intersection of N Delaware Blvd. As I followed the vehicle, I also noted it came close to striking the raised median curb several times. I activated my overhead interior emergency lights and siren to conduct a traffic stop. The vehicle's brake lights activated but it continued traveling westbound, through the light at Maplewood Dr., and into the left turn lane to turn into the Walmart parking lot. The vehicle crept up to the stop bar, stopped, and waited until the light turned green. When the light turned green, the vehicle turned into the Walmart parking lot and again crept to a stop. After stopping, I exited my vehicle and the SUV again began to proceed forward at which time, I verbally commanded the driver of the vehicle to stop.

### OBSERVATION OF DRIVER:

I observed the windows to the SUV were rolled down and that there were 2 large dogs inside the vehicle. I commanded the driver of the vehicle to turn the vehicle off and waited several seconds. The driver of the vehicle did not turn the car off. I slowly approached the vehicle and ordered the driver to exit. She did and almost immediately lost her balance, to the rear, stumbling over the curb. I asked the driver what her name and date of birth was and she advised Vasilea Mavrophilipos (w/f; 06/18/1987). I later confirmed Mavrophilipos had a valid Florida driver license. Mavrophilipos was extremely unsteady on her feet, slurring her speech, had bloodshot/glassy eyes, and the odor of an unknown alcoholic beverage on her breath which intensified as she spoke.

### DRIVER'S STATEMENTS:

Mavrophilipos advised multiple times that she had 2 "Long Island Iced Tea" beverages and that they went "straight to my head". I asked Mavrophilipos to estimate her level of impairment on a scale of 1 (being sober) to 10 (being sick) and Mavrophilipos advised she was a 5. Mavrophilipos stated she felt slightly under the influence. Mavrophilipos immediately consented to perform Standardized Field Sobriety Tasks, when asked.

### ODORS:

Odor of unknown alcoholic beverage coming from Mavrophilipos' breath which intensified as she spoke. Sweet smelling perfume aroma.

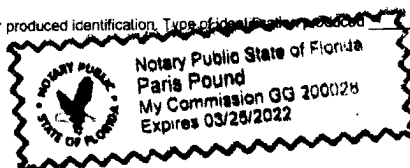

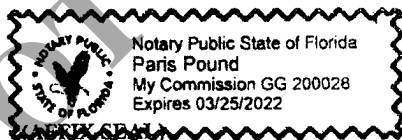

**Other Observations:**

I am a certified Drug Recognition Expert (IACP # 32395) and I conducted this task in accordance with my training. Mavrophilipos had pupils of equal approximate size, did not display resting nystagmus, and was able to track a moving stimulus equally. Mavrophilipos was swaying heavily throughout the duration of the task. VGN was not present.

**WALK & TURN:**

During the Instructions Stage, Mavrophilipos lost her balance (taking her front foot off the line) several times. After explaining the turn to Mavrophilipos, she asked for clarification on how to complete the turn and I demonstrated it again for her. Mavrophilipos then turned 360 degrees in a circle, practicing the turn. When told to begin, Mavrophilipos did not have her right foot in front of her left and was standing with her feet side by side. Mavrophilipos walked 8 steps down the line before turning. Mavrophilipos turned improperly by taking one additional step forward and pivoting on the balls of her feet. Mavrophilipos asked if her turn was proper and I advised her to complete the task as best as she could remember. On the return walk, Mavrophilipos missed heel-to-toe on step 8 and took a total of 9 steps down the line.

**ONE LEG STAND:**

Mavrophilipos elected to raise her right leg off the ground, standing planted on her left. On her count of 1007 and 1008, Mavrophilipos swayed noticeably. Mavrophilipos used her arms to balance on her count of 1013. Mavrophilipos placed her foot on the ground on her counts of 1013 and 1015. Mavrophilipos counted to 1017 before the end of the timed 30 second period.

**FINGER TO NOSE:**


Prior to administering the task, Mavrophilipos demonstrated knowledge of her left and right hands. The cadence for this task was: Left, Right, Left, Right, Right, Left. L1: Appropriately touched finger to nose. R1: Appropriately touched finger to nose. L2: Touched tip of left finger to septum (under nose). R2: Touched pad of right finger to tip of nose. R3: Initially raised left arm but corrected and touched pad of finger to tip of nose. L3: Touched tip of left finger to septum (under nose).

**ROMBERG ALPHABET:**

Mavrophilipos advised she had almost completed an Associate's Degree and that she was comfortable with the alphabet from A to Z. Mavrophilipos swayed from side to side throughout the duration of the task. Mavrophilipos appropriately recited the alphabet in a slow, non-rhythmic manner - as instructed.

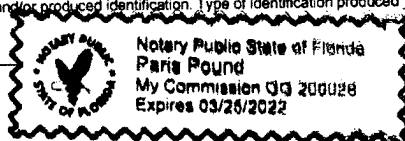
