The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

I observed the defendant driving a white Fiat with FL tag KDAL92 on N. Howard Ave from W. Kennedy Blvd. There was a police vehicle with all emergency lights active and a police officer on the roadside by that vehicle on N. Howard Ave. The road was straight and the emergency lights were clearly visible. The defendant was in the middle lane and the left lane was clear. She made no attempt to move over or slow down as she passed the police officer and his vehicle on the side of the road. I conducted a traffic stop and made contact with the defendant who was in the driver's seat. Upon contact with the defendant I could smell the odor of alcoholic beverages from her breath. Her eyes were glassy. She said she had 2 beers. She performed field sobriety exercises and showed impairment. Her breath alcohol content was .108 / .105.
