The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 05/02/2021 at approximately 0705 hours, I responded to the Seminole Hard Rock Casino Lucky Street garage ramp located at 5223 Orient Road Tampa FL 33610 in regards to a Simple Battery DV in progress.

Once on scene, I made contact with Suspect Veronica Ida Ledbetter (ID via FLDL), Victim Charles Dontale Collins (ID via DAVID), and Casino Security Officer Kenyon Mathis obtained a statement.

Suspect Veronica Ida Ledbetter stated, if anything it was her causing the problem. Ledbetter stated Collins did not strike her and it was just an argument. Ledbetter stated she pushed Collins on the chest because she was mad at him. Ledbetter stated the injuries to her right elbow occurred at Lollypops club located in Hudson. Ledbetter stated she did not know how Collins received injuries to his face. He works at a bar and he may have received them there.

Victim Charles Dontale Collins stated they were involved in an argument and it was not physical.

Casino Security Officer Kenyon Mathis stated he observed the vehicle come down the ramp of the garage and then came to a complete stop. Mathis looked through the back window and Collins and Ledbetter were physically fighting. Mathis observed Ledbetter turned around and physical fighting Collins as if she was the aggressor.

While on scene, I observed Ledbetter's right elbow to have several small scraps and was bleeding. I observed Collins to have scratches on the top of his forehead and the left side of his face to be red and swollen.

I noted that Collins and Ledbetter are girlfriend/boyfriend and have resided together for a year with no children in common.

Ledbetter was placed under arrest for Simple Battery DV and transported to the Orient Road Jail Central Booking.
