The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/13/2019, at approximately 0131 hours, the defendant was operating a 2017 blue Chevy Camaro bearing FL tag HMLC95 (VIN:1G1FB1RS9H0157240) northwest on Boy Scout Rd. The defendant failed to navigate the bend in the road and struck a TECO pole on the north side of the road. The defendant's vehicle continued and struck a fence before becoming stuck in a ditch. An anonymous witness contacted 911 and notified HCSO of the crash. Deputy R McKinnon responded to the scene and observed the defendant seated in the driver seat. Deputy McKinnon observed the driver side airbags had deployed and the defendant had minor injuries consistent with being in the driver seat. Affiant responded to the scene, detected signs of impairment, and requested the defendant perform field sobriety exercises which the defendant agreed to perform. During the exercises, the defendant showed signs of impairment and was subsequently arrested. The defendant provided a lawful breath sample which resulted in a BrAC of .189/.195. The defendant was identified via FL DL.							
Total Damage as a result of the crash is valued at approximately \$3,000.
