The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/08/2019, at approximately 2009 hours, at the intersection of Sun City Center Bl / Del Webb Bl E, Deputy Evarts# 4790 contacted the defendant on a traffic stop for driving off of the roadway and into the median (CIT #A95HORE). The defendant emitted an odor of an alcoholic beverage from his breath, he had slurred speech, bloodshot watery eyes, and he had unstable balance. Standardized Field Sobriety Exercises were conducted and impairment was observed. Based on the totality of the investigation, the defendant was arrested for DUI and provided two law breath tests of .229 and .216. The defendant was positively identified via a Mexico passport.
