On April 9th, 2022 at approximately 0451 hours, BBPD communications received a 911 call from the 100 block of S. Federal Hwy apartment community stating that the caller hears screaming from a female.

Officers and I responded to the residence and observed clothing in the Hallway outside of the door. While officers were walking towards the door a V1 was seen entering the building and upon the sight of Police officers (wore department insignia) turned around and started to run away from officers.

Officers was able to make contact with V1 who was detained. Post Miranda V1, provided a statement alleging that he had came home around 0200 and his girlfriend of 2.5 years W/F Victoria Marques (08/18/1994) had came home around 0230. V1 stated Marques had came home upset over relationship issues when she had got into the face of V1 and started to hit him with a open hand, throughout his neck and throat area. V1 stated that at no point did he defend himself. V1 stated that at no point did he push Victoria. V1 stated several times 'I let her hit me". V1 stated that Victoria screamed for no reason. V1 stated that he agreed to leave for the night and was gathering his items. While gathering his items he observed Officers and ran because he thought Victoria had contacted the Police. V1 invoked Marsy's Law and was provided with the pamphlet. V1 completed exempt from public records form. Domestic Violence brochure provided.

While making contact with V1, I observed red marks throughout areas of his neck and red marks on his chest and collar bone area. The red marks appeared to be fresh scratches. Photographs captured via BWC. V1 refused medical assistance.

I made contact with Victoria, who Post Miranda stated that her boyfriend of 2.5 years had battered her. Victoria stated that she had arrived home to V1, who was upset with her and started to push her against the wall/counter and chock her. Victoria stated that while she was being chocked she managed to scratch V1 in order to get away from him. Victoria stated that V1 continued to push her throughout the apartment and she screamed from help. While making contact with Victoria, I did observe her fingernail to be broken (From Scratching/Hitting). I checked the neck of Victoria and I did not observe marks or bruises to her neck. No other allegations or observations of injury was observed or mentioned. Photographed were captured via BWC.

Based on the above mentioned investigation I find probable cause to arrest Victoria. Based upon the physical evidence of visible injuries on V1's person coupled with the lack of evidence at this time for Victoria. Victoria invoked Marsy's Law and was provided with the pamphlet. V1 completed exempt from public records form. Domestic Victoria brochure provided.

Victoria was transported to BBPD and later TOT PBCJ.

V1 was advised on the next first appearance. V1 stated that he does not want to press charges.
