

On the 26 day of January, 2021 at 04:55 (Specifically include facts constituting cause for arrest.)

I UTILIZED MY DEPARTMENT ISSUED BWC DURING THE BELOW DESCRIBED INCIDENT:

On Tuesday, 01/26/20, I responded to the intersection of S. Alternate A1A and Toney Penna Drive in reference to a reported Welfare Check of a possible stranded driver. According to the caller, a vehicle was stopped at the above intersection with the driver behind the wheel.

As I was arriving, I could see the vehicle was stopped at the described intersection but began traveling north before I could pull in behind it. Officer Turner pulled in behind the vehicle and followed for a short distance (approx. 1/4 mile). The vehicle was driving at approximately 10mph to 15mph and weaved within its lane and also crossed over the lane divided land marker into the outside lane of travel. Officer Turner initiated a traffic stop by activating his overhead emergency lights and siren, signaling for the vehicle to stop. At this time, the vehicle was just south of the intersection of S. Alternate A1A and E. Indiantown Rd. The vehicle continued north through the intersection and made no attempt to stop, despite there being several safe areas and opportunities to pull over. Officer Turner continued attempting to stop the vehicle, a 1985 red Mercedes 4dr bearing FL-Tag BX5712, with negative results. As the vehicle continued north it continued weaving within its lane and crossed into the outside lane of travel several times. At the time I suspected the driver, later identified as Vincent A. Bolchoz (w/m, 03/09/98), might be intoxicated or suffering from unknown health issues, and as such there was a clear and present danger to the public. Both, Officer Turner and I were driving fully marked Jupiter Police Vehicles with all department insignias and jurisdictional markings prominently displayed on the vehicle. Both vehicles also had overhead emergency lights and they were also equipped with emergency sirens.

P R O B A B L E C A U S E	<p>The vehicle continued traveling north on N. Alternate A1A for approximately 1.5mi while Officer Turner and I were behind the vehicle with our emergency lights activated and Officer Turner`s emergency siren activated as well. Due to the driver`s unwillingness to stop, I did not activate my siren as I was responsible for providing updates for other responding Jupiter Police Officers. The vehicle made a U-turn on N. Alternate A1A at the intersection of Riverside Dr. and then continued traveling south on N. Alternate A1A for approximately three quarters of a mile before Sgt. Kimbark arrived to assist with boxing in the fleeing vehicle. It is important to note that the vehicle`s speed did not surpass 38 miles per hour, in a 45mph posted speed zone, and traveled and speeds between 10mph and 25mph during most of the incident.</p> <p>As the suspect vehicle passed Sgt. Kimbark`s location (Eganfuskee St. and S. Alternate A1A), I pulled in front of the vehicle and we executed a "Boxing in" maneuver. The vehicle safely came to a complete stop and a Felony Stop was conducted. Once Vincent was placed into custody I advised him of his Miranda Warnings which I read to him from a pre-printed card issued to me by the Jupiter Police Department.</p> <p>Vincent told me he understood the Miranda Warnings. During the interview, I asked him why he refused to stop for Officer Turner and me. According to Vincent, he did not know we were behind him. Vincent stated that he did not see the emergency lights and that he did not hear the emergency siren. Vincent advised he might not have heard the siren because he was listening to the radio and that he did not see the emergency lights due to the condensation of the rear window.</p> <p>At the time of the stop, I used my vehicle as the lead vehicle during the "Boxing in" maneuver. As such, when I exited my vehicle I could clearly see Vincent seated in the driver`s seat. When I looked at him as I ran back to assist with the Felony Stop, Vincent had a smirk on his face. During my above-described interview I did not hear Vincent slurring his speech, he did not have glassy bloodshot eyes, and I did not smell the odor of an unknown alcoholic beverage coming from his person. Vincent also appeared to be steady on his feet and told me he had two alcoholic beverages earlier in the evening. Due to the totality of the circumstances, I did not have reasonable suspicion that Vincent was driving under the influence of drugs or alcohol.</p> <p>As a result of my above-described investigation, in conjunction with his own statements regarding his failure to stop within a reasonable amount of time (despite having numerous safe locations to stop), I found Vincent did willfully flee or attempt to elude a law enforcement officer in an authorized law enforcement patrol vehicle with agency insignia and other jurisdictional markings prominently displayed on the vehicle with siren and lights activated, contrary to Florida Statute 316.1935(2).</p>
