The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 Sgt A. Portman stopped a red GMC Terrain bearing FL(85JDV) for suspicion of DUI after he observed it swerving outside of it's lane of travel, making a wide turn onto a surface street and unlawful speed of 40 MPH in a 25 MPH zone. Contact was made with the driver Vincent Charles Bruno who displayed multiple indicators of impairment to include having red glassy eyes, slurred speech and the distinct odor of an alcoholic beverage on his breath. He refused to do SFST's and was arrested for DUI. He was taken to CBT where he was read implied consent and refused to take the breath test. This is his second refusal, the first was on 03/18/17. Bruno's identity was verified using his Florida drivers license.
