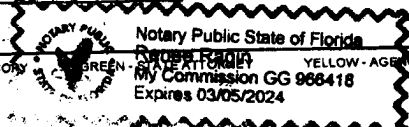

Upon commencing the Pen Light Task (HGN) the defendant moved their head side to side instead of following with their eyes only. During the task, I observed that the defendant had equal pupil size and did not exhibit resting nystagmus. The defendant's eyes tracked equally.													
	I then checked the defendant for Vertical Gaze Nystagmus (VGN). I saw distinct and sustained nystagmus at maximum deviation in both of the defendant's left and right eyes.

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

I was patrolling/monitoring traffic in the area of STATE ROAD 7 AND STRIBLING WAY when I saw the defendant's vehicle, a WHITE CHEVY 2500 bearing FL tag JRCB42, SPEEDING, 68MPH IN 50 MPH ZONE. The roadways were busy, Dry, Well lit. I activated my overhead emergency lights, stopping the vehicle.

OBSERVATION OF DRIVER:

I made contact with the defendant, later identified by their FL DL as, VINCENT NEIL. I observed that the defendant had red, watery, bloodshot eyes. The defendant had slowed, lethargic, speech, and the odor of an unknown alcoholic beverage, based on my training and life experiences, that came from their breath which intensified as they spoke to me. I asked the defendant if they had any medical problems or had taken any medications and the defendant said no. I asked how much they had had to drink. The defendant said, "A DRINK."

I asked the defendant to exit the vehicle. The defendant swayed while standing.

I asked the defendant to perform voluntary roadside tasks and the defendant consented.

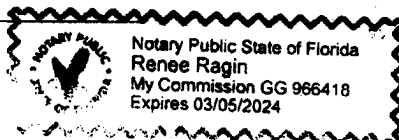

WALK & TURN:

I had the defendant place their left foot on the line with their right foot in front of the left, heel to toe. I instructed the defendant to remain in the position throughout my instructions and demonstration. The defendant was instructed not to start the task prior to me telling them to begin. The defendant acknowledged and stated they completely understood my instructions. The defendant was then instructed on the task which I also demonstrated. The defendant swayed during my instructions. The defendant came out of the stance prior to me telling them to begin. Once the defendant was told to begin the task they used their arms for balance, slowed to balance/steady themselves, and spontaneously stopped prior to completing the task. The defendant asked for additional instructions, and swayed throughout completing the task.

ONE LEG STAND:

The defendant was instructed to stand with their feet together and their hands down by their side. They were then instructed to remain in the position throughout the instructions and demonstration until instructed to begin. The defendant acknowledged and stated that they clearly understood the instructions. The defendant swayed while in the instructional position. After being told to begin the defendant put their foot down prior to being told to stop, used their arms for balance, and swayed.

FINGER TO NOSE:

The defendant was instructed to stand with their feet together and their hands down by their side. The defendant was then instructed to remain in the position throughout the instructions and demonstration until instructed to begin. The defendant acknowledged and stated that they clearly understood these instructions. The defendant swayed while in the instructional position. The defendant mimicked me by raising their arms prior to being told to start. I instructed the defendant on the task and demonstrated the task. The defendant acknowledged the instructions stating that they clearly understood them. The defendant did not tip their head back or close his eyes when told to begin as instructed. The defendant proceeded to miss/search for the tip of their nose with the tip of their finger, and anticipated which hand I would call. The defendant did not keep their head tilted back and/or opened their eyes during the task. The defendant swayed throughout the task.

MODIFIED ROMBERG:

The defendant was instructed to stand with their feet together and their hands down by their side. The defendant was then instructed to remain in the position throughout the instructions and demonstration until instructed to begin. The defendant acknowledged and stated that they clearly understood these instructions. The defendant swayed while in the instructional position. I asked the defendant if they knew the alphabet. The defendant stated they did. The defendant recited the alphabet.
