On the 14 day of November, 2020 at 03:48 (Specifically include facts constituting cause for arrest.)

Body Worn Cameras were utilized for the following incident:

On November 14th 2020, at approximately 0130 hours, I was dispatched to 1209 Main St. Apt. 210 in reference to a disturbance. North communication advised they heard a female yelling "let go of me" and "leave me alone".

Upon my arrival, a civilian walked by and advised there was a lot of yelling and loud banging in Apt. 210. As I approached the doorway of the apartment, I observed a white male standing in the doorway staring at officers. The white male was later identified as Vincent Patrick Mousseau (W/M - 05/10/1992). Mousseau appeared intoxicated, his eyes were glossy and he had slurred speech. Mousseau was approximately 6'1 and 210lb. As I attempted to make contact with the subject, he quickly jumped back into the residence and shut the door and I could hear the door locking. Officer Fandrey knocked on the door numerous times until a female subject who was later identified as Layton Virginia Byrd (W/F - 03/31/1992) opened the front door. According to Officer Fandrey Byrd appeared very frightened and was sobbing. Mousseau walked out of the residence and was standing next to officer Fandrey.

I attempted to speak to Mousseau who repeatedly yelled and talk over officers. Mousseau would not identify himself and would not give any information about what occurred in the residence. Mousseau became highly agitated towards officers. Mousseau continuously would not cooperate with officers. He would get angrier, his voice got louder and his face was turning flushed. Due to Mousseau being in a highly agitated state, lack of cooperation, Byrd's display of apparent fear, and uncertainty of the situation, Officer Fandrey and I attempted to place Mousseau in to handcuffs.

Officer Fandrey grabbed Mousseaus left arm and I placed Mousseaus right arm in an arm lock. Mousseau continued to be resistant and attempted to pull away from Officer Fandrey

and I. Due to Mousseaus size I gave verbal command for him on the ground. Mousseau failed to comply with my multiple lawful commands. As a result, I struck Mousseau's right thigh with my right knee as a distracting technique, and slowly directed him toward the ground for handcuffing. Officer Fandrey and I placed Mousseau into handcuffs which were double locked and checked for tightness.

I proceeded to make contact with Byrd who was still hysterically sobbing. Byrd also appeared intoxicated. Byrd advised she and Mousseau were in a verbal argument and nothing physical occurred. She advised Mousseau was very intoxicated and usually does not act like this. During my interview with Byrd, I observed the living room, which had items that appeared to be thrown around. It should be noted the apartment appeared to be in disarray. I utilized the F/NCIC database to which Mousseau was in violation of his probation for consuming alcoholic beverages.



I advised Mousseau he was being placed under arrest for resist without violence, disorderly intoxication and violation of probation.

Based on my investigation, I found probable cause to arrest Vincent Patrick Mousseau for disorderly intoxication because he was intoxicated or drank an alcoholic beverage in a public place or in or upon a public conveyance and caused a public disturbance, contrary to Florida Statute 856.011(1). (2 DEG MISD)

Based on my investigation, I found probable cause to arrest Vincent Patrick Mousseau for resist/obstruction because he did resist and obstruct A.O, a law enforcement officer of the *(Jupiter Police Department), in the execution of a legal process or in the lawful execution of a legal duty, without offering or doing violence to the person of such officer, contrary to Florida Statute 843.02. (1 DEG MISD)

Based on my investigation, I found probable cause to arrest Vincent Patrick Mousseau because he did violate his probation. F.S.S 948.06 *street violation, Palm beach 1805856*
