The defendant was informed that he was trespassed from the property for 365 days and if he returned he would be arrested for trespass after warning. Even after being verbally told that he could be arrested for trespass after warning the defendant continued to approach and enter the occupied establishment. The defendant entered the establishment a total of two times after being provided a verbal trespass warning. Due to the defendant entering the establishment multiple times after being trespassed, he was arrested for trespass after warning. The defendant verbally identified himself as Vitality Grebcoov (d.o.b. 09/19/1974) of Estonia. The defendant does not have any photo ID on his person and is from out of the Country and could not be positively identified at this time. The defendant was transported to Orient Road Jail, without incident.
