The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida did: On the above date and time, at the residence located at 16108 Gardendale Dr, the defendant and victim were engaged in a verbal altercation that turned physical when the defendant intentionally struck the victim multiple times in the face and body, against the victim's will.
