The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the above listed date and time, at the above listed offense location, Dep. Haugstad(#258204), conducted a traffic stop on a black Ford F150, FL tag GIZV86, for failure to stop at posted stop sign, failure to use turn signal, and unsafe change of lane. The defendant/driver also pulled directly in front of westbound traffic on 60 while exiting a private business. The defendant/driver was observed to have red, watery eyes, and the strong odor of an alcohol based beverage emanating from his person. The defendant was given the opportunity to perform field sobriety exercises, which he did poorly indicating impairment. Subsequent to arrest, the defendant provided breath samples of .054/.052% BAC after 20 minute observation period. The defendant was identified via Florida driver's license.
