The defendant and victim have been married for 15yrs and have been living together as a family the entire time with no kids in common. The defendant and victim were in a heated verbal argument in the living room over finances. The argument became physical when the defendant used his right index finger to flick the victim's nose against her will and without her permission. The victim walked away from the defendant to get away from him and went into another bedroom in the apartment. The defendant followed the victim into the bedroom to continue the argument. The defendant then grabbed the victim by both forearms and threw her to the floor against her will and without her permission. The victim asked her adult son who was in the apartment to call the police which he did. The victim sustained multiple contusions on both forearms where the defendant grabbed her. The victim refused all medical treatment on scene. The victim ID'd the defendant as the person who committed the battery/DV. A criminal history was ran on the defendant which returned with negative results on prior battery convictions.
