The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 5-12-2020 at approximately 2122 hours, the defendant was involved in a 2 vehicle crash where he made a wide right turn colliding with the drivers side of the victim/witnesses vehicle. The defendant was operating a silver Kia Stinger bearing Florida tag JXZM30 (VIN: KNAE45LC8K6044368) and caused approximately \$1000 of property damage. Upon my arrival, I was advised by the traffic crash investigator the driver of the Stinger was displaying signs of impairment to include bloodshot watery eyes and strong odor of an alcoholic beverage. I made contact with the defendant and asked if he would step out of the vehicle and in doing so he appeared unsteady on his feet. The defendant completed the SFSE's and displayed several more indicators of impairment. Once at CBT, the defendant provided 2 lawfully requested breath samples of 0.239/0.240%BAC. I issued the defendant DUI citation AA2S2PE for DUI with property damage. The victim identified the defendant as the driver of the vehicle and the defendant identified himself via Florida DL.
