On September 18, 2021 at or around 0328 hours, I responded to 2154 Zip Code Place, incorporated West Palm Beach County Sheriff's Office in reference to a disturbance.

Upon arrival, I made contact with management who advised all parties had departed however there was another intoxicated individual who was refusing leave. Moments later I made contact with Whitney Howard 8/6/1992. Howard advised that her friends who she arrived with had left her in which I and other deputies on scene were attempting to find her cab ride home.

During the course of attempting locate a sober ride, Howard attempted to grab my hand in which I asked her to stop. Howard briefly stopped before turning and attempting to try to hug me. I again asked Howard to stop in which she refused, continuing try to wrap her arms around me. At that time, I and two other Deputies placed her under arrest(double locked checked for fitment).

Based upon the aforementioned investigation, I find probable cause exist for Whitney Howard as she refused multiple lawful commands pursuant to F.S.S 843.02.
