ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE MICHAEL JUNIOR, HIS EX-BOYFRIEND, AGAINST THE WILL OF MICHAEL JUNIOR, TO-WIT: THE DEFENDANT STRUCK THE VICTIM SEVERAL TIMES CAUSING SWELLING TO HIS RIGHT ELBOW AND A SCRATCH ON HIS LEFT HAND THAT WAS FRESH AND BLOODY.

THE DEFENDANT AND VICTIM WERE INVOLVED IN A ROMANTIC DATING RELATIONSHIP FOR APPROXIMATELY A YEAR AND HAVE RECENTLY BROKEN UP BUT STILL STAY IN CONTACT. TONIGHT THE DEFENDANT WAS INTOXICATED AND ARRIVED TO THE VICTIM'S HOUSE WHERE THE TWO BEGAN TO ARGUE. DURING THE ARGUMENT IT TURNED PHYSICAL AND THE VICTIM WAS STRUCK BY THE DEFENDANT SEVERAL TIMES CAUSING VISIBLE INJURIES TO THE VICTIM'S LEFT ARM AND LEFT HAND.

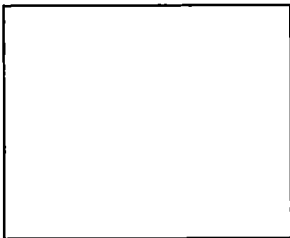
