The defendant was driving a 2019 Toyota SUV bearing a Florida license plate of LFMZ67. He was traveling west on W Kennedy Blvd near S Armenia Ave and made a lane change from the number one lane to the number two lane and almost struck the curb. As I followed the defendant he weaved back and forth in his lane multiple times. A traffic stop was conducted and upon making contact with the defendant he displayed multiple indicators of impairment, to include; bloodshot watery eyes, slurred speech, fumbling fingers trying to get his door open, an odor of an alcoholic beverage, and an unsteady stance. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .235/.222.

The defendant was identified by his FL DL.
