The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was driving a blue 2018 Porsche bearing a Florida license plate of IZBY31. He was traveling west on W. Kennedy Blvd at S Armenia Ave. I was directly behind the defendant's vehicle and he accelerated extremely quickly to a high rate of speed, over 60 MPH in a 40 MPH zone. As the defendant approached S. Macdill Ave there was a disabled vehicle in the number one lane (with its lights on) and the defendant failed to observe this vehicle until the last second, swerving to avoid a collision. Then, accelerating again to over 60 MPH in a 40 MPH zone. This was paced with my calibrated and certified police vehicle. A traffic stop was made and upon making contact with the defendant he displayed multiple indicators of impairment; to include; watery and bloodshot eyes, droopy eyelids, an odor of an alcoholic beverage, unsteady stance, and an admission to consuming alcohol (two mixed alcohol drinks), and an admission to smoking marijuana today. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the Implied Consent Warning.

The defendant was identified by his FL DL.
