On the 6 day of April, 2021 at 01:05 A.M. P.M. (Specifically include facts constituting cause for arrest.)

On April 4th, 2021 at approximately 01:00 hours, I was dispatched to 1528 North Oceanbreeze within the city of Lake Worth Beach, Palm Beach County, Florida in reference to a Battery.

Upon my arrival I met with a white male later identified as William E. Schmitt, his girlfriend white female Leila Horne, and white female Leanna Horne. I first spoke to Leanna Horne who told me that she went out for her sisters Leila's birthday, and her boyfriend Schmitt, and while they were out Schmitt had been acting extremely rude to her, and treating her with a lot of disrespect. Leanna Horne told her that she wanted to go home, and asked her to call an Uber for them because she did not want to go back home with Schmitt.

Schmitt convinced both Leanna Horne, and Leila Horne to go back home with him, and he would take them back to their car. While they were driving back to Schmitt's home, Leanna Horne and Schmitt began to argue. At this time Leanna Horne started to record Schmitt because he was saying extremely vulgar things to her. Leanna showed me the video which showed Schmitt telling Leanna Horne she liked black guys, and Leanna Horne asked him if he was racist. Schmitt then is seeing aggressively turning around, and grabbing Leanna Horne's phone.

When they arrived to Schmitts home, Leana Horne, and Leila Horne exited the vehicle, then Schmitt physically attacked Leanna, hitting her on the lips, leaving a, bruised, bloody bottom lip.

I spoke to Leila Horne who said that her boyfriend Schmitt was acting very "cocky" all night, and being really mean to her sister Leanna. Leila Horne said that she asked Schmitt to take them home, and on their way back home, Schmitt continued to be disrespectful. Leila Horne said that when they arrived home, they exited the vehicle, and saw Schmitt fighting her sister Leanna, so she tried to separated them.

Due to the above statements, facts, and physical evidence I found that William E. Schmitt did actually and intentionally touch or strike Leanna Horne against her will and did intentionally cause bodily harm to Leanna Horne contrary to Florida Statute 784.03(1).
