The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 01 day of FEBRUARY, 2020,

at approximately 12:48 AM, at MAIN ST / DOUGLAS AVE, in Pinellas County did:

UNLAWFULLY OBSTRUCT OR OPPOSE DEPUTY BRENNEN WEDE, A DULY AND LEGALLY CONSTITUTED LAW ENFORCEMENT OFFICER OF THE PINELLAS COUNTY SHERIFF'S OFFICE, WHILE IN THE LAWFUL EXECUTION OF A LEGAL DUTY, WHICH CONSISTED OF INVESTIGATING A VERBAL DOMESTIC ALTERATION WHICH OCCURRED IN MY HIS PRESENCE, THAT WITHOUT OFFERING OR DOING VIOLENCE TO THE PERSON OF THE OFFICER.

AT THE ABOVE DATE AND TIME, I WAS CONDUCTING ROUTINE PATROL IN THE AREA OF DOWNTOWN DUNEDIN WHEN I OBSERVED A MALE AND FEMALE ARGUING ON THE SIDEWALK. I PROCEEDED TO GET OUT AND MAKE CONTACT WITH THEM. I ADVISED BOTH PARTIES TO STOP SO I COULD INVESTIGATE WHAT WAS OCCURRING. THE DEFENDANT REFUSED TO COOPERATE WITH ME AND TOLD ME TO "FUCK OFF" BEFORE WALKING OFF. I LAWFULLY ADVISED THE DEFENDANT MULTIPLE TIMES TO STOP SO I COULD CONDUCT MY INVESTIGATION, BUT THE DEFENDANT REFUSED TO COMPLY WITH MY LAWFUL COMMANDS AND KEPT ON WALKING AWAY. I ATTEMPTED TO GRAB A HOLD OF THE DEFENDANTS LEFT ARM DUE TO HIM REFUSING TO COMPLY WITH MY LAWFUL COMMANDS, BUT WHEN I GRABBED THE DEFENDANTS ARM, HE IMMEDIATELY RIPPED HIS ARM AWAY FROM ME AND TRIED TO KEEP WALKING AWAY. I WAS ABLE TO GRAB A HOLD OF BOTH OF THE DEFENDANTS ARMS AND SECURE HIM IN HANDCUFFS. I SPOKE TO THE DEFENDANT, WHO ADVISED HE SHOULD HAVE LISTENED TO ME AND COMPLIED WITH MY LAWFUL COMMANDS DURING MY INVESTIGATION.

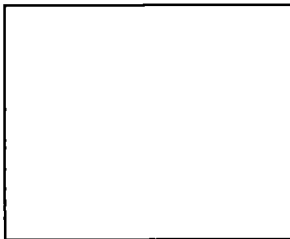
