

(Specifically include facts constituting cause for arrest.)</p> <p><b>On 8/9/2021, at approximately 2:47 PM, I was parked in the northeast corner of Lucerne Avenue and S.R. 805 (Dixie Highway), in the City of Lake Worth Beach, Palm Beach County, Florida 33460. I was monitoring the two posted no turn on red signs for westbound Lucerne Avenue as you approach the intersection of S.R. 805. At that time, I saw a Grey Chevrolet Tahoe bearing Alabama tag #50CA823, westbound on Lucerne Avenue, approaching the intersection of S.R. 805, where the traffic signals were red for westbound Lucerne Avenue. I saw the Grey Tahoe make a right turn and proceed northbound on S.R. 805, from Lucerne Avenue, from the north turn lane, in violation of the posted no turn on red signs (see Florida Uniform Traffic Citations #AF0W6ZE).</b></p> <p><b>I activated my emergency lights and attempted to stop the Grey Tahoe which accelerated rapidly while northbound on S.R. 805, from Lucerne Avenue. I was able to stop the Grey Tahoe in the 600 block of N. S.R. 805, where it pulled into the gas station parking lot at 632 N. S.R. 805.</b></p> <p><b>I made contact with the Grey Tahoe's Driver/Defendant William Edward Wood, W/M, 3/24/1973 (identified by the Florida DL the Defendant showed). Upon making contact with the Defendant I immediately smelled a strong, putrid odor, of an unknown alcoholic beverage emanating from his breath. Upon taking to the Defendant the odor became stronger and more noticeable. The Defendant also had reddened, glassy eyes, and a flush face. I briefly checked the Defendant's eyes while he was sitting in his car using my black pen as a stimulus. I noted distinct and sustained Nystagmus at maximum deviation, and a lack of smooth pursuit in both eyes. The Defendant stated he was coming from Dave's Last Resort (a local bar in the City of Lake Worth Beach), he drank four draft beers, his first beer was at approximately 12-12:30 PM and his last was at approximately 2:30 PM. The Defendant further stated he was taking Xanax in the proper dosage, for anxiety, had Covid, (later stated while at Main Jail's BAT, to me, that it was two weeks ago and he no longer has Covid), and that he has no other medical issues.</b></p>

<p><b>I had the Defendant exit his vehicle and attempted to conduct the Horizontal Gaze Nystagmus (HGN) task on the Defendant. The Defendant had a slight saw from side to side, kept moving his head, and would not track the stimulus (tip of my black pen) at times. When the Defendant would track my stimulus, I noted distinct and sustained nystagmus at maximum deviation, lack of smooth pursuit, and an onset of nystagmus prior to 45 degrees in both eyes.</b></p> <p><b>Based upon the totality of the circumstances I suspected the Defendant may be driving under the influence. I contact another Deputy Sheriff via my cell phone, to respond to my location, to conduct a DUI investigation. D/S Lester Escaran #32415 responded to my location. I turned the DUI investigation over to him.</b></p> <p><b>The Defendant was later arrested for DUI per F.S.S. 316.193(1)(A). Per the Defendant's request (see in-car video) I turned his property over to his significant other Mr. Junior Vicente Herrera Juarez, H/M, 6/2/1995 (identified by the Florida DL he showed me). I inventoried the Defendant's Grey Tahoe which was later towed by D and D Towing.</b></p> <p><b>I responded to the Main Jail's BAT and completed my paperwork. This concluded my involvement with this case.</b></p>

(Specifically include facts constituting cause for arrest.)</p> <p>On 8/9/2021, I was in service in Palm Beach County performing under an Occupant Protect Grant. I was called to assist Cpl. Karlecke 6467 on a traffic stop in the area of 7th Ave N and North Dixie Highway, Lake Worth Beach 33460, due to a possible impaired driver.</p> <p>Upon arrival, I made contact with Cpl. Karlecke, who advised that he had stopped the dark gray SUV for failing to obey the traffic control sign, 'NO TURN ON RED'. Cpl. Karlecke advised that as he was speaking with the driver, who was identified by FL DL as William Wood 3/24/1973, he observed an odor of an unknown beverage, Mr. Wood admitted to having four alcoholic beverages, and having red bloodshot glassy eyes.</p> <p>I then made contact with Mr. Wood who was still in the dark gray SUV in the driver's seat. Upon contact I observed Mr. Wood to have watery, red and blood shot eyes and an odor of an unknown alcoholic beverage coming from the interior of the SUV. I then requested Mr. Wood to exit the SUV and to walk to under shade of the covered gas station and he complied. Upon Mr. Wood exiting the SUV, I observed Mr. Wood to have an unsteady gait. As Mr. Wood began speaking to me outside of the SUV, I observed Mr. Wood to have an odor of an unknown alcoholic beverage coming from his mouth area and breath. Once Mr. Wood was under the covering of the gas station I asked him what happened today and he stated that he ran the red light at Lucerne Ave and Dixie Highway and that he always runs that light by turning right on red. He advised that he knows that there is a sign that states no turn on red. He then stated that he is fine to drive one mile down the road. I asked him if he had anything to drink and he stated no. I asked him if Cpl. Karlecke was lying to telling me that he was advised by Mr. Wood's that he had alcoholic beverages today. Mr. Wood stated yes. And then stated that earlier maybe he had alcoholic beverages but didn't want to get into it. He advised that he is ok to drive. He then stated to go ahead and take him to jail. I asked Mr. Wood if he would be willing to perform roadside exercises and he stated no. I then advised him of the Taylor Warnings and asked him again if he would be willing to perform roadside exercises and he stated no and to not tow his car. Once Mr. Wood refused to perform the roadside exercises, he was placed under arrest for DUI. Mr. Wood was handcuffed and checked for proper fit.</p> <p>Mr. Wood's property on his person were taken off of him and given to his significant other. The vehicle was towed by D &amp; D towing.</p> <p>Mr. Wood was then placed in the rear of my marked patrol car and safety belt was fastened. Mr. Wood was then transported to the Palm Beach County Jail.</p> <p>Upon arrival to the Palm Beach County Jail, Mr. Wood was escorted to the Breath Alcohol Testing Center where a 20 minute observation was conducted to ensure that he did not take anything by mouth or regurgitate. After the 20 minute observation was completed, Mr. Wood was then escorted to the testing room and was requested to submit to a lawful sample of his breath. He refused to do so. I then advised Mr. Wood of the implied consent and he advised that he understood. I requested Mr. Wood again if he would be willing to submit to a lawful test of his breath and he refused again. This was taken as a refusal to submit at approximately 1629 hours. Mr. Wood was then advised of his Constitutional Warnings and he advised that he understood. Mr. Wood was asked questions and began answering them but ultimately refused to answer any further questions. Mr. Wood was then escorted to a holding cell and removed from handcuffs.</p> <p>Upon the completion of paperwork, Mr. Wood was escorted to Palm Beach County Sheriff's Office Booking desk for processing.</p> <p>Mr. Wood was placed under arrest for Driving Under the Influence F.S.S. 316.193(1).</p>

Upon arrival, I made contact with Cpl. Karlecke, who advised that he had stopped the dark gray SUV for failing to obey the traffic control sign, 'NO TURN ON RED'. Cpl. Karlecke advised that as he was speaking with the driver, who was identified by FL DL as William Wood 3/24/1973, he observed an odor of an unknown beverage, Mr. Wood admitted to having four alcoholic beverages, and having red bloodshot glassy eyes.

I then made contact with Mr. Wood who was still in the dark gray SUV in the driver's seat. Upon contact I observed Mr. Wood to have watery, red and blood shot eyes and an odor of an unknown alcoholic beverage coming from the interior of the SUV. I then requested Mr. Wood to exit the SUV and to walk to under shade of the covered gas station and he complied. Upon Mr. Wood exiting the SUV, I observed Mr. Wood to have an unsteady gait. As Mr. Wood began speaking to me outside of the SUV, I observed Mr. Wood to have an odor of an unknown alcoholic beverage coming from his mouth area and breath. Once Mr. Wood was under the covering of the gas station I asked him what happened today and he stated that he ran the red light at Lucerne Ave and Dixie Highway and that he always runs that light by turning right on red. He advised that he knows that there is a sign that states no turn on red. He then stated that he is fine to drive one mile down the road. I asked him if he had anything to drink and he stated no. I asked him if Cpl. Karlecke was lying to telling me that he was advised by Mr. Wood's that he had alcoholic beverages today.

## OBSERVATION OF DRIVER:

Mr. Wood stated yes. And then stated that earlier maybe he had alcoholic beverages but didn't want to get into it. He advised that he is ok to drive. He then stated to go ahead and take him to jail. I asked Mr. Wood if he would be willing to perform roadside exercises and he stated no. I then advised him of the Taylor Warnings and asked him again if he would be willing to perform roadside exercises and he stated no and to not tow his car. Once Mr. Wood refused to perform the roadside exercises, he was placed under arrest for DUI. Mr. Wood was handcuffed and checked for proper fit.

Mr. Wood's property on his person were taken off of him and given to his significant other. The vehicle was towed by D & D towing.

Mr. Wood was then placed in the rear of my marked patrol car and safety belt was fastened. Mr. Wood was then transported to the Palm Beach County Jail.

Upon arrival to the Palm Beach County Jail, Mr. Wood was escorted to the Breath Alcohol Testing Center where a 20 minute observation was conducted to ensure that he did not take anything by mouth or regurgitate. After the 20 minute observation was completed, Mr. Wood was then escorted to the testing room and was requested to submit to a lawful sample of his breath. He refused to do so.

## DRIVER'S STATEMENTS:

I then advised Mr. Wood of the implied consent and he advised that he understood. I requested Mr. Wood again if he would be willing to submit to a lawful test of his breath and he refused again. This was taken as a refusal to submit at approximately 1629 hours. Mr. Wood was then advised of his Constitutional Warnings and he advised that he understood. Mr. Wood was asked questions and began answering them but ultimately refused to answer any further questions. Mr. Wood was then escorted to a holding cell and removed from handcuffs.

Upon the completion of paperwork, Mr. Wood was escorted to Palm Beach County Sheriff's Office Booking desk for processing.

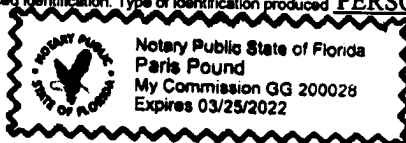

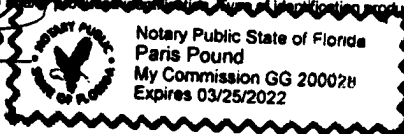

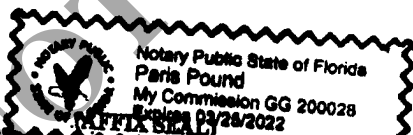
