The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was operating a gray 2015 Jeep Cherokee, 4 door, Florida tag HAMT51. The defendant passed another vehicle in a no passing zone by passing to the left crossing over a double solid yellow lane divider line. The defendant then failed to come to a complete stop before making a right turn against a steady red traffic light. A traffic stop was conducted for these traffic violations. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed. The defendant was evasive with questions related to alcohol consumption, not directly answering the question then ultimately claiming to have not consumed alcohol. A 7-Eleven beverage container was in the center console of the vehicle, which was determined to contain a cold alcoholic beverage. The defendant denied possessing this beverage or to whom it belonged. The defendant swayed mildly while standing. The defendant refused to submit to Field Sobriety Exercises, despite being advised what the purposes of the FSE's were for and possible consequences of his refusing to participate in the FSE's. The defendant exhibited signs of impairment, and based on a totality of the circumstances he was placed under arrest for DUI. The defendant refused to submit to a lawful test of his breath for the purpose of determining its alcohol content after being advised of the Implied Consent Warnings. The defendant was positively identified by his Florida DL.
