## NARRATIVE:

On July 26th, 2021 I was assigned this case for follow up investigation. Complainant John Jamason reported observing child exploitation material on his client, William Hatch's, laptop while repairing it. Jamason agreed to turn over the laptop and provide a statement the following day.

On July 27th, 2021 I met with Jamason at the North County Government Center located at 3188 PGA Blvd. so that he could turn over the laptop and provide a statement. The interview with Jamason was digitally recorded, authorized persons may review the recording for accuracy and details. The following is a brief summary of Jamason's statements. Jamason explained he runs a computer repair business and a client he has previously done work with requested to have a laptop's hard drive transferred to a new one. Jamason stated this client, William Hatch, has previously requested work going as far back as 2018. Jamason told me his relationship with Hatch is strictly through business, he does not know him personally. Jamason stated he drove to Hatch's residence located at 4132 Ixora Ct. North in the area of Lake Worth on Sunday July 25th, 2021 and picked up three laptops belonging to Hatch.

Jamason told me of the three laptops he picked up, only one was in working condition. He stated he was tasked to transfer the working laptop's hard drive into a new laptop. Jamason said he began to work on the laptop on the same Sunday. Jamason stated he was the only person in possession of the laptop and no one else had access to it.

Jamason stated he removed the hard drive from the old laptop, and while scanning the aforementioned hard drive for viruses before transferring it to a new laptop he discovered what he believed to be child pornography files. Jamason explained he observed file folders labeled "small children" and "young boys" inside a "One Drive" file folder. Within this "One Drive" folder Jamason stated he opened four to five image files which he explained were of young children "having sex with each other". Jamason articulated he observed an image of an eleven-year-old girl performing oral sex on an adult male. He also observed images of naked boys and girls who were ten years old. Jamason stated he believes there are "hundreds" of child pornography files, indicated by their file names, everywhere on Hatch's computer.

Jamason defined child pornography as children under the age of eighteen, and could determine that the individuals he observed in the images were children from personal experience of having children of his own. Jamason then handed the laptop over to me. He showed me where he found the files located on "Quick Access" located on the file explorer. While under the "Quick Access" folder listed under "Recent files" I observed the following files:

- Filename: 10 yr nudist girl.jpg

Description: A naked prepubescent girl (approximately 9-11 years of age) standing in front of the camera. This image could be considered "Child Erotica".

- Filename: three 10 yr old nudist girls.jpg

Description: Three naked prepubescent girls (approximately 9-11 years of age) standing in front of the camera. This image could be considered "Child Erotica".

- Filename: dad mouth fuk 15 yo teen daughter

Description: A clothed pubescent girl (approximately 15-17 years of age) sitting and performing oral sex on an unknown naked male subject. The female subject pictured in this image could be considered "Age Difficult".

- Filename: 13 yo daughter exposed on internet 3

Description: A naked pubescent girl (approximately 15-17 years of age) posed with her breasts and vagina exposed. The female subject pictured in this image could be considered "Age Difficult".

I also observed a folder named "GIRL 10 AND BELOW" located under the "Frequent folder" selection as well. The title of this file folder is indicative of possibly containing child pornography. "Child Erotica" is a term used for material or items that are sexually arousing to persons having a sexual interest in minors but that are not necessarily, in and of themselves, obscene or that do not necessarily depict minors in sexually explicit poses or positions or meeting the legal definition of child pornography. "Age Difficult"

is a term used in child pornography investigations to describe a file depicting sexual conduct or lewd or lascivious acts of an individual with the physical features of a juvenile and an estimated age of 15-17 years old, but more information would be needed to determine their actual age. The Lenovo laptop was later submitted into evidence.

On July 28th, 2021 Honorable Judge Robert Panse signed a search warrant for Hatch's laptop. On the same day, the laptop was submitted to Digital forensics to obtain possible evidence.



On July 29th, 2021 after an initial digital triage forensic examination, I viewed four image files which depicted child sexual abuse material as per Florida State Statute 827.071. The file information and descriptions are listed below:

- Filename: tween show pussy.jpg  
MD5: ad9dbef18da13abae1cafbcb6572a7583  
Description: A naked pubescent girl (approximately 10 - 12 years of age) laying down, posing with her breasts and vagina exposed in a seductive manner.
- Filename: boy sucking boy 54.png  
MD5: e76a1e1aa27bc902c88770c56d979126  
Description: A pubescent boy (approximately 10 - 13 years of age) performing oral copulation with an unknown male subject's penis.
- Filename: 0000001\_Carved.jpg  
MD5: 72dd88cd46663a9f82cdff3aa4b2b4c9  
Description: A naked pubescent girl (approximately 10 - 12 years of age) engaging in sexual activity with an unknown male subject who is positioned behind, they appear to be engaged in sexual intercourse.
- Filename: 0000002\_Carved.jpg  
MD5: 316a32b4d7ae553794147c473757540c  
Description: A naked pubescent girl (approximately 10 - 12 years of age) sitting with her vagina exposed in a sexual manner.

Also found during the forensic examination was an image of Hatch's Florida driver's license.

Due to the facts derived from my investigation I found that William K. Hatch Jr. did unlawfully and knowingly possess, control an image, Hatch knew to include any sexual conduct by a child contrary to Florida State Statute 827.071(5)(a).
