

Body camera and in car video were activated for the traffic stop. It should be noted, the collision was not captured on either camera.

This Officer witnessed a blue two door sedan back into a parked white sedan. The blue vehicle then drove past this Officer, who was in a parked police unit #16474, without attempting to report the collision. This Officer conducted a traffic stop on the vehicle, a blue Lexus (DSF54/FL), in the same parking lot. This Officer made contact with the driver of the vehicle, identified via Florida Driver License photo, William Djubin (SU), while he was still in actual physical control of the vehicle.

Djubin had several indicators of obvious impairment, such as the following: bloodshot watery eyes, flushed red face, heavy droopy eyelids, slow slurred speech to the point of incoherence, slow reactions to commands and questions, and a strong obvious odor of an unknown alcoholic beverage emanating from his breath at conversational distance. When asked to exit the vehicle, Djubin was very slow and deliberate in his movements. Djubin had great difficulty understanding simple commands, such as to lean on the patrol vehicle's push bumper until told to move. Djubin walked with a very unsteady gait and was unable to stand up straight. When asked how much Djubin has had to drink, he replied "too much".

This Officer requested Djubin to participate in Standardized Field Sobriety Exercises, to which he declined. This Officer advised Djubin of his Taylor Warnings, to which he again refused to comply. This Officer placed Djubin under arrest at approximately 1940 hours. During incident to arrest search of Djubin's person, receipts were discovered in his back right pocket.

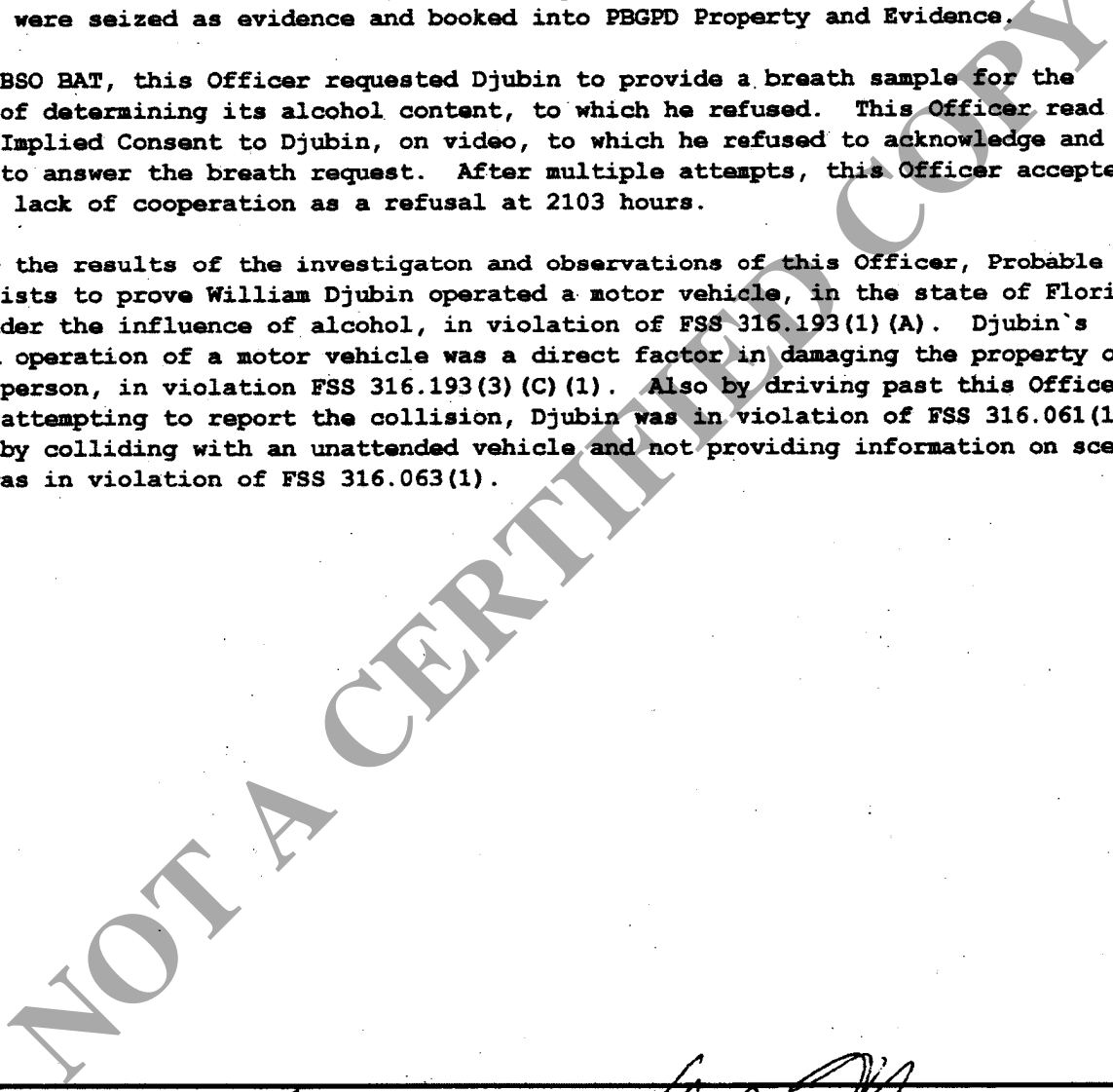

This Officer spoke with the bartender whom served Djubin, Jamie Petronaci (IO) who said Djubin had to be cut off after excessive consumption of alcoholic beverages. Petronaci provided this Officer with an itemized receipt of Djubin's purchases. The receipt showed the following items: Bottle of Mollydooker The Boxer (\$67.00) and Bottle of Orin Swift Abstract (\$68.00).

During an inventory check of Djubin's wallet, this Officer discovered a receipt, from the same location and on this date, for two Espresso Martini's (\$16.00 each). All receipts were seized as evidence and booked into PBGPD Property and Evidence.

At the PBSO BAT, this Officer requested Djubin to provide a breath sample for the purpose of determining its alcohol content, to which he refused. This Officer read Florida Implied Consent to Djubin, on video, to which he refused to acknowledge and refused to answer the breath request. After multiple attempts, this Officer accepted Djubin's lack of cooperation as a refusal at 2103 hours.

Based on the results of the investigation and observations of this Officer, Probable Cause exists to prove William Djubin operated a motor vehicle, in the state of Florida, while under the influence of alcohol, in violation of FSS 316.193(1)(A). Djubin's impaired operation of a motor vehicle was a direct factor in damaging the property of another person, in violation FSS 316.193(3)(C)(1). Also by driving past this Officer without attempting to report the collision, Djubin was in violation of FSS 316.061(1). Lastly, by colliding with an unattended vehicle and not providing information on scene, Djubin was in violation of FSS 316.063(1).

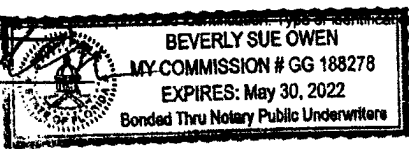

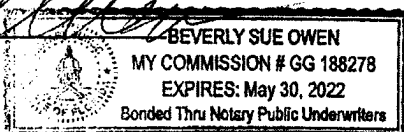

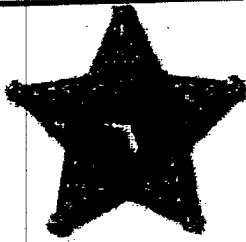
