The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was driving a 2002 blue Chevy SUV bearing a Florida license plate of NRMX66. He was traveling east on the Gandy Bridge (inside the city limits of Tampa) and was weaving back and forth multiple times, touching the lane dividers. A traffic stop was made and upon making contact with the defendant he displayed multiple indicators of impairment, to include; droopy eyelids, constricted pupils, slurred speech, unsteady walk/stance, fumbling fingers, dry mouth, and an admission to consuming Zoloft (daily) and an admission to consuming Kratom. The defendant stated he was taking the Kratom as he was driving, just before I pulled him over. I also noticed a large amount of green residue around the defendants mouth, shirt, and pants. A search incident to arrest revealed a large bag of green powder, believed to be Kratom, inside the center console. Also, on the passengers side floor board of the defendants vehicle were several hundred empty C02 cartridges (whippets). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a urine test despite acknowledgment of the Implied Consent Warning.

The defendant was identified by his FL DL.
