The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 07 day of FEBRUARY, 2020,

at approximately 3:20 AM, at 6755 W FLAMINGO WAY S, in Pinellas County did:

ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE DIONDRA CAMERON, HIS GIRLFRIEND AND CO-HABITANT, AGAINST THE WILL OF DIONDRA, TO-WIT: PUSHING, STRIKING AND SPITTING ON DIONDRA.

ON THE ABOVE DATE AND TIME, THE VICTIM AND THE DEFENDANT WERE ARGUING INSIDE THEIR RESIDENCE. DURING THE ARGUMENT THE DEFENDANT SPIT ONTO THE FACE OF THE VICTIM AND THEN THREW A PUNCH AT THE VICTIM, WHICH GRAZED ACROSS HER NECK. THE DEFENDANT THEN GRABBED THE VICTIM BY THE ARMS AND TACKLED HER ONTO THE FLOOR AND PUT ALL OF HIS BODY WEIGHT ONTO HER. AS THE DEFENDANT TOOK THE VICTIM TO THE GROUND, THE VICTIM'S STRAP ON HER SHIRT SNAPPED.

TYLER MERRELL WAS INSIDE THE RESIDENCE AND WITNESSED THE OFFENSE. THE DEFENDANT SPONTANEOUSLY STATED HE PUSHED/SHOVED THE VICTIM. PHOTOS WERE OBTAINED FOR EVIDENCE.

IN THIS CASE, THE VICTIM AND THE DEFENDANT LIVED TOGETHER AS BOYFRIEND AND GIRLFRIEND AND AS A FAMILY UNIT.

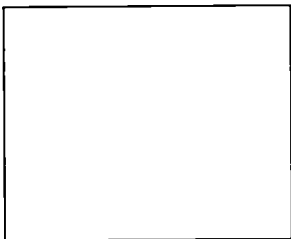
