The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 09/05/2021 at approximately 1937hrs, affiant conducted a vessel stop on a multi colored 16' Scout boat bearing FL6986KF / Hin: SLPE55271798 with 1 Seddon Channel Tampa, Hillsborough County, FL 33606 for the purpose of a safety inspection. Upon stopping the vessel, affiant made contact with the operator/defendant, who was standing at the helm in control of the vessel. During personal contact with the defendant, affiant observed him to have blood shot watery eyes and had a strong odor of an alcoholic beverage coming from his breath as he spoke. Due to this, affiant requested the defendant perform seated field sobriety task to determine if he was operating a vessel while under the influence of an alcoholic beverage and/or controlled/illegal substance. The defendant refused to perform the task. Based on the totality of the circumstances, affiant arrested the defendant for BUI. The defendant was advised Florida Implied Consent (2029hrs). The defendant stated he understood and refused to provide a breath sample. The defendant verbally identified himself and produced a Florida drivers license.
