at approximately 1:22 AM, at 18121 GULF BLVD, REDINGTON SHORES FL, in Pinellas County did:

DEFENDANT WAS THEN AND THERE DRINKING AN ALCOHOLIC BEVERAGE IN A PUBLIC PLACE (FRIENDLY TAVERN) OR IN OR UPON A PUBLIC CONVEYANCE AND DID CAUSE A PUBLIC DISTURBANCE.

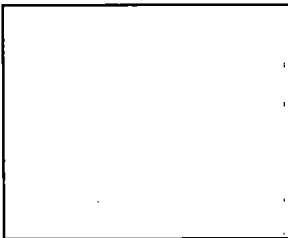
