| The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did<br>On the listed date and time, Deputy Ferguson #254546 observed a gray, Nissan Murano bearing FL tag KADA89 weaving in and out of its lane, as well as crossing into the southbound lanes of Lakewood Dr while still traveling northbound almost striking oncoming traffic. Deputy Ferguson then contacted me advising me of his observations. Deputy Ferguson was transporting an arrestee to the Orient Road Jail and could not conduct a traffic stop on the above mentioned vehicle for safety reasons. Once I was able to relocate directly behind the before mentioned vehicle, I immediately observed it drifting from left to right in its lane while jerking the steering wheel after over correcting. I then observed the vehicle cross into the southbound lanes of traffic while traveling northbound on Lakewood Dr multiple times. I conducted a traffic stop on the vehicle due to Deputy Ferguson's observations and my observations as well. Upon contact with the driver, the driver emitted an odor of an alcoholic beverage from his breath, he had fumbling fingers while retrieving his documents, had bloodshot and watery eyes, and unstable balance. Field sobriety exercises were conducted and impairment was observed. The driver was arrested for DUI and provided two lawful breath samples (BrAC .120/.126) after Implied Consent warning was read and understood. The driver admitted having consumed one, 24oz Yuengling Lager, and a single Jai Alai beer prior to the traffic stop tonight during post-Miranda interview. A DAVID query of the driver showed one prior guilty DUI conviction on 03/02/2005.
