

<p>On 07/18/2021 at approximately 2149 hours, I responded to the area of Spanish River Blvd and Military Trail in reference to a traffic complaint of a white Mercedes vehicle not moving in the middle of the road. Upon arrival, I observed a white Mercedes vehicle bearing FL tag DCGJ25 on Spanish River Blvd just east of Military Trail in the second left turn lane to make a southbound turn onto Military Trail. Upon my arrival, I observed a black female later identified by her FL DL to be Woodline Pierre Louis, stumbling from the vehicle and then turn around once she saw me and sat back into the driver seat of the vehicle and closed the driver side door. Ofc Bachar arrived on scene shortly prior to me and advised he saw Pierre Louis stumbling from the driver seat of the vehicle prior to me. (See Ofc Bachar's supplemental report for further details).</p> <p>I immediately knocked on the driver side window to make contact with Pierre Louis to conduct a welfare check on her as her vehicle was in the middle of the road. Pierre Louis opened the driver side door and told me she needed help getting home because her car stopped. She then asked me if she was in trouble. I advised her that before we began talking, I wanted for us to get off to the sidewalk and not in the middle of the roadway for our safety. She then stated, "I'm in trouble, I'm sad." I then told her again that I just wanted her to get out of the middle of the roadway, and I then guided her to the sidewalk in a safe, well-lit dry surface area. I then asked her what happened and why her vehicle was in the middle of the roadway. Pierre Louis replied stating her car had stopped working. I then asked her for her identification, so I knew who I was speaking to, and she began looking in her purse for it. She then pulled out a number of cards, including her FL DL which I saw in her hand and then she placed it back in her wallet. She then asked for my help. While she continued to look for it, I asked her if she needed the fire department to check her out. She replied she did not. I also asked her if she was having any medical episodes, and she stated no, her car had just stopped working. While speaking with Pierre Louis briefly, I observed her to be swaying back and forth, her speech was slurred, her eyes were bloodshot and glossy, and I could smell an</p>

<p>odor of alcohol coming from her breath and person. Based on these observations, I became concerned that due to Ofc Bachar and I both having observed her being in actual, physical control of the white Mercedes vehicle bearing FL tag DCGJ25, she was under the influence. I then began conducting a DUI investigation.</p> <p>I then asked Pierre Louis where she was coming from. She replied, "heading home." I asked her where her home was, she stated "Boca." I then asked her where in Boca, and she replied "Palmetto and Military Trail." I then asked her again where she was coming from before her vehicle was here, and said "to get home." I then explained to her that I understood she was going home, but I wanted to know where she was coming from, and she again replied "headed home." After asking her multiple times, she continued to reply "I'm headed home," and could not answer my question coherently. I then advised her that I was concerned that she might be impaired, and I was concerned for her ability to drive. I asked her if she had anything to drink, and she replied, "Nope, I'm A-Ok." I asked her if she was taking any prescription medications, and she stated she is not. I then asked her if she has any medical conditions and she replied she does not. I then asked if she has any physical injuries, and she replied she does not. I then advised her that I wanted to conduct a series of field sobriety tasks to dispel my alarm that she was under the influence. Pierre Louis immediately stated she did not want to do any tasks. I then began to advise her of her Taylor Warnings: that if she does not want to perform the tasks, I will be forced to base my decision on whether or not she is under the influence based on what I have observed. While advising her of this, Pierre Louis began to talk over me, so I repeated it again so she heard me. She replied stating she was "A-Ok." I then explained to her that her refusal to perform the tasks can also be used in a court of law. She replied again stating "No alcohol," and she was "A-Ok" and "sober." Pierre Louis would repeatedly ask me if she could call her boyfriend to pick her up, and I advised her that she cannot make any phone calls right now. She then began to dial her phone and call someone, so I then secured her in handcuffs, double-locked and checked for proper fit and advised her that she is detained in handcuffs because she was not listening to me. She then replied, "I'm A-Ok, I haven't had one drink tonight." I then advised her that she is swaying back and forth, she's slurring her speech, I can smell an odor of alcohol on her breath and person, and she could not answer my simple question of where she was coming from. She replied by stating, "I'm headed home, that's the only place I'm heading from." She then stated she went to the gas station to get gas and a red bull.</p> <p>Based on my observations of Pierre Louis along with her refusal to submit to the field sobriety tasks I requested of her, I then advised Woodeline Pierre Louis that she was under arrest for driving under the influence. I conducted a search of Pierre Louis's person and placed her into my marked police vehicle. A local FCIC/NCIC check on Woodeline Pierre Louis revealed that she has a prior suspension for refusal to submit to lawful test of breath, urine or blood. I then transported her to the PBSO BAT. While enroute to PBSO BAT, Pierre Louis advised that she will "sue the Fort Lauderdale Police</p>

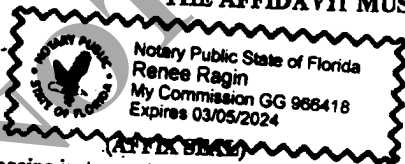

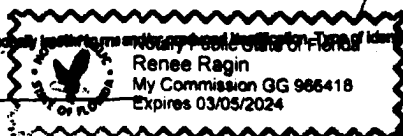

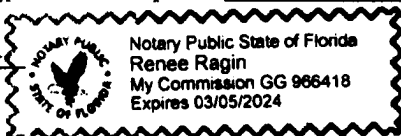
