 On 09/25/2021 at 0102 hours I responded to Marlin Av W at Bayshore Bl after Tampa Police Sgt Sean Davis(44436) conducted a traffic stop on grey 2021 Honda Civic FL tag KMPQ43 after he observed that the vehicle had no lights on at night, strike a curb, and drive over the median. Upon contact with the driver, defendant Yadira Altagracia Dejesus, Sgt Davis observed signs of impairment. Suspecting that the defendant was impaired he requested a DUI unit. Upon my arrival I made contact with the defendant and observed that she had extremely blood shot glassy eyes and as I spoke with her I detected a distinct odor of an alcoholic beverage. The defendant then indicated that she was coming from a house party. I then asked the defendant to perform the SFSEs and she exhibited additional signs of impairment. At which time I placed the defendant under arrest for DUI based on all of my observations made thus far in my investigation. The time of arrest was 0119 hours. I then transported the defendant to the HCSO/CBT Facility where she submitted to a breath test. Her BAC was .175/.178. I identified the defendant with a PA DL.
