


On February 8, 2021 at 2203 hours, I responded to 5700 W. Glades Road (Macy's) in reference to a shoplifting.

Upon arrival I made contact with Loss Prevention Officer, Juan Rodriguez, inside their office. Rodriguez provided me the following statement: While he was watching video surveillance inside the business, he witnessed two white females selecting various items from the women's department. After selecting the items, both women entered the fitting room area with shopping bags. Shortly after, the females exited the fitting room area with only the shopping bags in their hands, the shopping bags also appeared to be bulkier than when they entered. The females then repeated the process once more in a different fitting rooms. It should be noted, Loss Prevention Officer Balian, entered the fitting rooms immediately after the females left, and did not locate any of the items the two took with them, which indicates the females concealed the items inside the shopping bags they original brought with them. At approximately 2106 hours, both females walked out of the south entrance of the business (inside), passing all points of sale. At this point, Rodriguez stopped both females and took them to the loss prevention office until police arrived on scene.

After, I reviewed the video surveillance of the incident which confirmed Rodriguez's observation of the theft. Rodriguez then provided a copy of the footage which was later submitted into evidence.

I then met Camila Valladares Lopez and her mother, Yadira Lopez, both verified by their Honduras identifications. I first spoke with Camila who was read her Constitutional Warnings from a pre-printed card. Camila verbally acknowledged she understood and wished to speak to me regarding the incident. According to Camila, she and her mother, concealed various clothing items while they were inside the business. Camila admitted to taking clothing items to the fitting room and placing the items inside their shopping

At this time, Officer Castillo responded and read Yadira her Constitutional Warnings, which she agreed to speak to him. Officer Castillo advised Yadira admitted to stealing the clothing. Yadira advised she and her daughter entered the fitting room and place various clothing items inside their shopping bags multiple times before exiting (see his supplement for further).</p> <p>At that time, I informed both Camila and Yadira they were both under arrest for retail theft. Based on my investigation, loss prevention's statement/video, and both Camila Yadira admitting to concealing the items in an attempt to deprive the business of their property, I developed probable cause to arrest Camila and Yadira for Retail Theft, pursuant to F.S.S. 812.015(8) (A). Both Camila and Yadira knowingly and intentionally stole clothing, valued at \$1,945.44 with the intent to deprive the business (Macy's) of their property. Officer Luciano from FAU PD responded to conducted a search of the females which yeilded negative results. Camila and Yadira were then transported to the Boca Raton Police Department and later transported to the Palm Beach County Jail.</p> <p>Nothing further.</p>
