The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 07-05-2020, at approximately 1910 hours, at 1903 Vandervort Road, Lutz, FL 33549 the defendant and victim were involved in a verbal argument which escalated to physical violence when the defendant intentionally slapped the victim in the side of the head and face, against his will. The victim sustained visible injuries including a laceration to his left ear, and a bite mark on his right arm. The victim positively identified the defendant as the person who committed the offense.
