The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 01/31/21, at approximately 1446 hours, A verbal altercation ensued between the defendant and co-defendant after the co-defendant damaged the defendant's sons vehicle. The altercation turned physical when the defendant walked aggressively towards the co-defendant and attempted to strike the co-defendant. The defendant and co-defendant engaged in a mutual affray. The co-defendant responded by intentionally striking the defendant in the face with a closed fist. The defendant received a small laceration on his chin, a small laceration on the bridge of his nose, and a small laceration on his left hand.
