 On the above listed date and time, at the above listed location, Deputy Jacobs #254973, was operating his marked patrol vehicle. Deputy Jacobs conducted a traffic stop on a white Honda Civic bearing Florida tag: ICSG01, due to the vehicle almost hit his vehicle. Upon making contact with the defendant, Deputy Jacobs detected indicators of impairment. Upon my arrival, I requested the defendant to perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to perform. During the exercises, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant agreed to provide two lawful breath samples to determine her breath alcohol content (BAC). After a proper 20 minute observation period was conducted, the defendant provided two lawful samples of his breath. First BAC sample (.221); Second BAC sample (.227). The defendant received a DUI citation #A6UW0SE, which reflects the DUI charge. The defendant was identified via her Florida Driver's License.
