On Saturday, September 11th, 2021 at approximately 2158 hrs while in the area of Southern Blvd and Cleary Rd, in unincorporated West Palm Beach, Palm Beach County, Florida, 33415 I observed a black Infiniti 2DR bearing Florida License Plate EKZI93 traveling west bound in the west bound number 2 lane of travel at an extremely high rate of speed.

I proceeded to follow the vehicle which I visually estimated to be traveling in excess of 105 mph in a posted 50 mph zone as I caught up to the vehicle I began a pace of the vehicle utilizing a unmarked calibrated Palm Beach County Sheriff's Office Patrol Vehicle asset number 56111 during the pace I observed the vehicle maintaining speeds between 95mph and 100mph I observed the vehicle change lanes several times without signaling almost colliding with other vehicles.

I initiated a traffic stop on the vehicle in question utilizing red and blue lights which the unmarked patrol vehicle is equipped with the Infiniti continued west bound through Benoist Farms Rd moving into the west bound number 1 lane of travel without signaling the vehicle came to stop in the west bound number 1 left turn lane of Southern Blvd just east of Sansbury Way.

I made contact with the driver who was the sole occupant of the vehicle at the open drivers side window where I immediately notice a strong odor of an unknown alcoholic beverage emanating from the driver person. I requested his license, registration, and proof of insurance, he provided his license an insurance but was sow to provide his registration, I noted his photograph affixed to his driver license which identified him as Yankov Rodriguez Alvarez.

PERSONAL CONTACT

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

D/S Blackman (#8396) observed, in the area of Southern Blvd and Cleary Road, in unincorporated West Palm Beach, Palm Beach County, Florida, a black Infinity vehicle bearing Florida tag EKZI93 traveling westbound on number 2 lane of Southern Blvd at an extremely high speed. He visually estimated the speed at 105 mph in a posted 50 mph zone. He caught up with the vehicle and paced it between 95 and 100 mph. He also observed the Infinity changing lanes several times without signaling, almost colliding with other vehicles. D/S Blackman initiated a traffic stop and the driver and only occupant of the vehicle was identified by his Florida driver license as Yankov Rodriguez Alvarez. Rodriguez Alvares was also the registered owner of the vehicle.

OBSERVATION OF DRIVER:

D/S Blackman observed Rodriguez Alvarez was slow to provide his registration. A strong odor of unknown alcoholic beverage was coming from the driver. His eyes were red and watery and he was sweating.

I approached the driver and observed that he had bloodshot and glassy eyes. He was sweating I also smelled an obvious odor of unknown alcohol beverage that became stronger when he talked. His speech was slurred.

DRIVER'S STATEMENTS:

Rodriguez Alavarez stated that he drank three beers around 7 pm.

Obvious odor of unknown alcoholic beverage

Bloodshot and glassy eyes. Pupils round and of approximate equal size. No resting nystagmus. Onset of HGN at approximately 35 degrees. No vertical gaze nystagmus. No lack of convergence. Swayed during the task.

WALK & TURN:

Rodriguez Alvarez could not maintain the instructional stance. When asked to start the task, he did not touch heel to toe on every steps.

ONE LEG STAND:

Rodriguez Alvarez raised his left foot. He swayed and put his foot down back to the ground on his count of 1003. He then raised it again and restarted counting from 1001. The task ended on his count of 1028.

FINGER TO NOSE:

Rodriguez Alvarez swayed. He used the pad of his finger instead of the tip on all tasks.

ROMBERG ALPHABET:

After confirming that he knew his alphabet, Rodriguez Alvarez recited it and stopped at the letter S. For the modified Romberg balance, Rodriguez Alvarez stopped the 30 seconds count at approximately 38 seconds. He swayed during the task.


