NARRATIVE:

On Monday, 03/22/2021, Your Affiant assumed investigative lead for a shooting call that occurred on 03/20/2021 at the 'Bamboo Room' located at 25 South J Street, Lake Worth Beach, FL. The City of Lake Worth Beach has landmarked this area as the neighborhood of 'Downtown Jewel'

(https://lakeworth.maps.arcgis.com/apps/webappviewer/index.html?id=5291a926002b44caa330fafa17899c82) that encompasses the area just south of downtown Lake Worth between Lucerne Ave and 6th Ave South and Federal Highway and Dixie Highway. It is a 'mixed-use' area consisting of both, residents and businesses.

The 'Bamboo Room' is located on the west side of South J Street, just north of 1st Avenue South. There is an entry/exit facing South J Street and an entry/exit to the west alleyway. The structure has an indoor area as well as a 1,025 sq. ft. courtyard space that includes a balcony overlooking the main floor. There is a two-story apartment complex across the street (east) and a three-story, multi-unit apartment building to the south. Both of the apartment buildings have balconies and courtyards where residents can congregate outside.

The 'Bamboo Room' specializes in renting out space for events, such as weddings, receptions, small-venue concerts, corporate retreats, etc. The business holds beverage license #BEV6004564 4COP which allows for beer, wine and liquor, to be consumed on the premises. The business manager, Darrin Cummings, BM, 10/13/1972 is responsible for overseeing the premise and was present the night of this incident.

Overview:

On Saturday, 03/20/2021 a MMA (Mixed Martial Arts) Amateur Championship fight took place between Alexis Fernandez and Filipe Valentim at the 'Bamboo Room'. These fighters are associated with two separate 'fight clubs'; Alexis Hernandez is out of Miami, FL associated with 'Team MMA Cuba' and Filipe Valentim is out of Boca Raton, FL associated with 'American

Combat Gym'. The Championship fight, as well as those prior, were organized by 'RIZE Fighting Championship' (RIZE FC) operated by Armando Gonzalez, 08/05/1970.

Supporters of Alexis Fernandez purchased six (6) tables at \$1,200 each to view the fight(s). These tables were closest to the octagon, just behind the judge's tables. A copy of the 'RIZE FC' sponsor form was obtained by Your Affiant showing these tables were purchased using VISA credit card bearing name 'Yasmani Hernandez' billing address 16861 N.W. 79th Place, Miami Lakes, FL 33016, telephone (786) 707-9958. A second telephone number was provided (786) 352-2311. Review of the name, address, and telephone numbers identified Yasmani Hernandez Romero, WM, 12/07/1989 as the purchaser.

'Team MMA Cuba' & Hernandez Family:

- Antonio Hernandez Montes De Oca, WM, 07/16/1964 is father to Yasmani Hernandez Romero. Hereafter referred to as Hernandez Montes De Oca.
- Hermelinda Olivia Romero Cabreja, WF, 03/03/1963 is wife to Hernandez Montes De Oca. Hereafter referred to as Romero Cabreja.
- Yasmani Hernandez Romero, WM, 12/07/1989 is son to Hernandez Montes De Oca and Romero Cabreja. Hereafter referred to as Hernandez Romero.
- Rosmery Estevez Hernandez, WF, 11/02/1992 is wife to Hernandez Romero. Hereafter referred to as Estevez Hernandez.
- Eduardo Suarez Grueiro, WM, 11/24/1994 is a bantamweight MMA fighter and twin brother to Ernesto Suarez Grueiro. Hereafter referred to as Eduardo Suarez Grueiro. Difference between twins: Eduardo's head is shaved just above his ears, he wears a red jogging suit with white stripes down the arms/legs.
- Ernesto Suarez Grueiro, WM, 11/24/1994 is a bantamweight MMA fighter and twin brother to Suarez Grueiro 1. Hereafter referred to as Suarez Grueiro. Difference between twins: Ernesto's head is not shaved and he has a beard.
- Alfredo Rafael Garcia Capote, WM, 12/19/1996 is a MMA fighter. Hereafter referred to as Garcia-Capote.

Numerous cellphone videos taken by victims, spectators, and media were provided to Your Affiant. Most of the videos start at the conclusion of the championship fight and continue as events unfolded. None of the videos are date/time stamped. Thus, Your Affiant reviewed all video clips and derived the case facts using the clearest video with the best angles. Your Affiant labeled each video in bold where case facts supporting a criminal event where observed.


Video MMA Bout

At approximately 2257hrs, the fight was 'called' by the referee in favor of Filipe Valentim. As the referee checks on Fernandez, Rosmery Estevez-Hernandez is standing behind the Judges table. Estevez-Hernandez looked to her right where Eduardo Suarez-Grueiro and Alfredo Rafael Garcia-Capote are standing near the entry/exit gate to the octagon. Estevez-Hernandez motioned with her left hand for them to go in the octagon – which is against MMA rules.

During celebration, Valentim walked towards Fernandez's corner and threw his arms up in the air in a taunting motion. The referee stops Valentim from walking any closer to Fernandez's corner and ushers him back to his side of the octagon. As one of his coaches lifted up Valentim, one of Fernandez's coaches entered the octagon to assist him. With the gate remaining open, Eduardo Suarez Grueiro tried to enter. He was wearing a red jogging suit with white stripes down the arms/legs and unknown words with 'CUBA' in white lettering on the back. He has short, black hair with the sides over his ears shaved. As he stepped onto the mat, he is pulled back down the stairs by an unknown male. Two more coaches entered the octagon to assist Fernandez, again leaving the gate open. As they neared the entry/exit, Garcia-Capote, wearing a short-sleeved black tee shirt with 'GARCIA' across the back tried to enter. He too was pulled back from the gate and down the stairs. Valentim's supporters begin chanting which caused Suarez-Grueiro and Garcia-Capote to become more agitated. Garcia-Capote continued his attempts to enter the octagon and had to be physically restrained while Fernandez, his couches, and the fight promotor where trying to exit.



As Garcia-Capote was being calmed down an unknown white male from Valentim's team ran across the octagon. Garcia-Capote also saw the commotion and ran across the spectator area to where Hernandez-Romero and Estevez Hernandez were standing near opposing fans.



Garcia-Capote imposed himself in the middle of a heated discussion until someone pulled him back away from the groups. As Estevez Hernandez, who was wearing an all-black dress, turned to walk back to her table, Hernandez-Romero, also wearing all black clothing, picked her purse up off the floor and Garcia-Capote returned to entry/exit gate of the octagon. The camera then switched back Garcia-Capote who had two hired security guards and an unknown male yelling at him to "GO!" as he pushed Garcia-Capote away from the octagon.



As the guards and Garcia-Capote's associates calmed him down the camera panned back to other side where a large group of people were in a melee. In the front is Hernandez-Romero who was arguing with a bald headed white male wearing a black tee shirt with 'Garcia' on the back. Estevez Hernandez is standing behind him with Eduardo Suarez Grueiro over her shoulder and Hernandez Montes De Oca to his right, wearing a maroon polo shirt and blue jeans. As Hernandez-Romero continued to argue crowd became more agitated with people pushing, shoving and yelling.



As Hernandez-Romero and Estevez Hernandez are ushered away from the confrontation, a hookah is in Hernandez-Romero's right hand. An unknown black male continued to push Hernandez-Romero and Estevez Hernandez backwards causing her to fall to the floor. Eduardo Suarez Grueiro stepped between the opposing groups as Hernandez Montes De Oca continued to walk backwards with his arms spread out and hands shaking back and forth in attempt to calm the crowds. Seconds later, an unidentified black male, that was attempting to calm everyone, was struck by a plastic cup containing an unknown liquid thrown from the balcony area. As the black male looked up, MMA Judge John Rivera bent down and proceeded to cross under a retractable belt barrier to exit the facility. Upon getting his head and shoulders under the belt, Rivera was struck in the face by a white folding chair thrown by Estevez Hernandez.

Hernandez Montes De Oca is standing with his arm out, hand up in a 'stop' motion as tensions continued escalating. John Rivera, baldhead wearing light green short-sleeved shirt is standing on the backside of the retractable belt barrier – closest

to the octagon. Hernandez-Romero is at the bottom of the frame still holding the hookah in his right hand. Two unidentified men are holding onto him trying to get him to go towards the exit.



As the camera/phone pans down, Estevez Hernandez comes into view holding a white folding chair in her right hand and her purse in her left. She swung the chair from behind her, took an extended step forward with her left leg and hurled the chair through the air striking John Rivera in his face as he went under the tethered barricade. Rivera's injuries are described in detail, along with a synopsis of his sworn taped statement under PBSO Case #21-047310.





Rivera fell to the floor then regained his composure after assisted by a male standing behind him. After the chair struck Rivera, an unknown male wearing a mint green tee shirt with a large graphic and two-toned baseball cap, grabbed Estevez Hernandez around the neck from behind. The male forcefully dragged her towards the exit door, but was grabbed by Hernandez-Romero causing all three of them to land on the floor.





Rivera then tried to charge Estevez Hernandez, but an unknown person, wearing all black clothing, grabbed Rivera from behind pushing him past the fallen group. As Rivera and the man ran past, Hernandez Romero smashed the glass hookah over the head of the man in the mint green tee shirt. Hernandez Montes De Oca then slammed a white folding chair over the head and back of the man in the mint green tee shirt as he laid on Estevez Hernandez.



Security guards broke up the melee, removing Estevez Hernandez to the side and an unknown male grabbed Hernandez Montes De Oca around his throat as he still had hold of the folding chair, and dragged him to the ground.

Just as the parties separated, Garcia-Capote is at the bottom of the screen holding a white folding chair with both hands. He proceeded to hurl the chair across the room striking bystander, Gustavo Camejo in his face.



Capote-Garcia is then shoved by a white male wearing black gloves, a dark colored tee-shirt, and camouflage shorts.

Hernandez Montes De Oca regained his footing and walked to his wife, Romero Cabreja who was standing in the middle of the spectator seating area. Hernandez Montes De Oca took Romero Cabreja's purse from her left arm, walked to an abandoned table and began rifling through the contents. After several seconds, he picked the purse up off the table and walked to another table while still searching inside. With both of his hands inside the purse, he looked to his right and left checking the crowd. Seconds later, he removed a black firearm with his left hand from the purse.



Hernandez Montes De Oca turned around and while placing the firearm in his right hand, chambered a round then dropped the firearm by his side. He walked over to the first table, lifted his right arm up and fired a single shot into the air. The gunpowder from the firearm can be seen dispersing in the air when the video is played frame-by-frame.





An unknown male, wearing a black tee shirt with 'CUBA' on the front and 'RIZO' on the back immediately approached Hernandez Montes De Oca motioning for him to put the firearm away, but Hernandez Montes De Oca shoved him away as the firearm flailed in his right hand. A second man, wearing all black clothing with a black baseball cap (on backwards) and full beard engaged Hernandez Montes De Oca to which he waved the firearm in the man's face and pushed him out of the way.

Multiple screams occurred as people began running out of the event and onto the roadway. Hernandez Montes De Oca continued to walk around, pointing the firearm at patrons as he attempted to get them to exit the premise. Quickly thereafter, security escorted him outside.

Video-2021-03-20-23-23-26(1)

This video clip was recorded from the left side of the octagon. It starts with Garcia-Capote being calmed down in the corner. Approximately forty-seconds into this clip Hernandez Montes De Oca is captured firing one shot into the air. It should be noted, when Hernandez Montes De Oca fired the shot the second floor balcony was occupied by numerous spectators.







Video-2021-03-20-23-42-59

This video is taken from the opposite side of the octagon and starts prior to the shooting when the initial melee begins. Approximately 30 seconds into the clip, video shows Hernandez Montes De Oca fire the single-shot in the air. The remainder shows the crowd dispersing, the owner of this video (unknown) running off the octagon and hiding on the opposite side. It also captured several people being tended to for unknown reasons on the floor of the octagon.

Palm Beach County Deputies arrived on scene at 2301hrs reference a firearm being shot inside of the club. Lead Deputy Sheriff Goodman #26786 was told by remaining patrons the 'shooter' already left premise. DS Goodman and backup deputies conducted a cursory sweep of the establishment for gunshot victims that met with negative results. DS Goodman did state some patrons appeared to have minor lacerations consistent with hand-to-hand fighting, but no one wanted to file a report. A crime scene was established next to the alleyway entrance/exit where a single nickel-plated, Federal Cartridge Company bullet casing was located. While DS Goodman was speaking with John Rivera about his injury and events leading to same, he advised a second nickel-plated Federal Head stamped 9mm shell casing was located at 35 South J Street and 1st Avenue South.

Calls were made to PBSO Dispatch advising of a second shot being fired, but there were no witnesses or video. Both shell casings were subsequently secured in PBSO Evidence and will be analyzed to determine if they were fired from the same firearm.

PBSO Case #21-050642 – Victim Gustavo Camejo

Your Affiant reviewed the CAD reports for this call and determined victim, Gustavo Camejo met with PBSO deputies on 03/22/2021 to file a criminal report for injuries he sustained during the melee. Mistakenly, responding DS Lasso gave Camejo the case number for the 'shots fired' (PBSO Case #21-047025) call and not a new case number. This issue was resolved and Camejo provided a separate case number from the original event.

On 03/30/2021, Your Affiant reached out via text message to Camejo concerning his case. Via text messages, Camejo advised he was able to identify the person that threw the chair and hit his head. Your Affiant asked how to which Camejo replied he saw him in video posted by 'NBC' then sent me the link "Caught on Video: Brawl Erupts Outside Ring at MMA Match in Lake Worth" (https://www.nbcmiami.com/news/local/caught-on-video-brawl-erupts-outside-ring-at-mma-match-in-lake-worth/2411634/). Camejo advised, "Open the article and watch the video . . . at around 1 minute – 1:08 I believe . . . his name is Alfredo Garcia, he was a fighter on the card that night". Camejo then sent two still pics taken from the video:






Camajo texted "He registered w RIZE as fighting out of 'Cuban MMA gym' in Miami....same gym who the shooter afiiliated with – I can identify both him and the shooter if needed – I also have other videos/pictures from that night, my injury, the brawl etc. Whatever you need."

Camejo sent Your Affiant a series of texts (printed out and attached to the filing packet as well as submitted to evidence) with links to videos and websites containing information related to the MA bout, fighter Alfredo Garcia, the melee, and injury he sustained from the chair thrown by Alfredo Garcia.







On 04/02/2021, Your Affiant completed a taped sworn interview with Gustavo Camejo, WM, 05/18/1988, residence 4500 North Flagler Dr. #A14, West Palm Beach, FL. On 03/20/2021, Camejo attended the MMA bout with friends from his MMA gym. They reserved a VIP table that was located near the octagon. Initially, Camejo said he arrived at the venue after the second fight, but would later change this stating he in fact was there for the first fight. At the end of the championship fight, Camejo was standing approximately 20' away from their VIP table because the area by his table was overcrowded and their view was obstructed. Once the championship fight ended the people directly to his right, who were supporting the 'Cuban MMA Gym' got very angry, throwing things into the octagon and the opposing team and team supporters. He heard them scream that their fighter was illegally hit and the ref did not call it. That's when the opposing spectators started to retaliate by stepping forward yelling obscenities back.

Camejo said he was standing off to the side trying to keep people away from himself and friends. Then he saw a woman throw a chair and strike a man in his head. The woman was then taken down to the floor and that man was struck on the back with a chair by another man. Camejo said because this was so close to him, he focused on these people and was trying to get out of there. Then seconds later, someone threw a chair over crowd that hit me two inches above his left eye. He said he never blacked-out, but he was disoriented and then heard the gunshot and people screaming. Realizing he was bleeding he was not sure if he was hit with a bullet. His friends rushed him out and over to the paramedics. Camejo then went to 'Brogue's' which is a restaurant around the corner from 'Bamboo Room'. He went to the restroom to clean his face and wait for his friend to drive him to JFK Hospital where he received treatment.

Camejo did not see the male throw the chair, but when he went online, he located the 'NBC' video that captured the incident. Camejo then recalled that 'Garcia' fought earlier that night and looked him up on the 'RIZE FC' website:

https://www.rizefc.com/ determining that Garcia was registered to 'Cuban MMA Gym' which is the same gym had a fighter in the championship fight and whose supporters incited violence in the audience. Camejo said he has never met Garcia before and he has never heard of 'Cuban Gym MMA' or Alfredo Garcia.

Camejo received medical treatment for a large laceration to his forehead requiring eight stitches to close the wound. A CT Scan was conducted which did not show brain injury, but he did suffer a concussion. He missed Monday, 03/22/2021 to file a police report and contact physicians for follow-up. His employer requested that he fly to Greenville to meet a client, but his doctor advised not to due to the concussion. For complete, accurate details regarding the information learned during the interview, authorized persons should review the audio CD interview in its entirety.

Your Affiant positively identified suspect, Alfredo Rafael Garcia Capote, WM, 12/19/1996 using the same websites as Camejo. Using the software program 'Intellitech' Your Affiant, placed Garcia Capote's DAVID photograph from 07/23/2019 in position number #5 alongside five other similarly featured white men. The photograph, printed in black and white, was placed inside a PBSO Instruction pamphlet.

On 04/07/2021, Det. Gareau met Camejo arrived at 860 US Hwy 1, North Palm Beach, FL and presented him the photo lineup while audio recording. Gareau read the instructions aloud, provided a pen to Camejo then walked away leaving him to review the photo lineup alone. After moments, Camejo circled the male in position number five (5) – Alfredo Rafael Garcia Capote. Camejo advised he was done initialed next to each line of instructions and signed the pamphlet. Det. Gareau secured the completed photo lineup and returned same to me on 04/08/2021. A copy of the lineup was made and the original placed into PBSO Evidence. Det. Gareau advised in his supplemental report he placed a copy of the audio file in evidence as well.


PBSO Case #21-47310 - Victim John Rivera

On 03/22/2021, Your Affiant left a message on John Rivera's phone requesting a return call. At 1950hrs, Your Affiant received an email from Rivera with an attached video titled 'Rize Championship Brawl.mp4' with a text message "Bamboo Room – John Rivera (Green Shirt) that was assaulted by Hispanic Female by throwing a chair causing injury to left eye." There were nine photographs (review evidence for all photographs) attached depicting injury to his left eye sustained by the thrown chair.










At 2025hrs, Rivera sent texts advising he is available to discuss the incident and would send (text) pictures and social media account profile (for the suspect). Rivera sent the following pics and text messages:

















On 03/26/2021, a telephone interview was conducted with John Rivera, WM, 06/23/1967, 2003 NW 74th Way, Pembroke Pines, FL. For complete, accurate details regarding the information learned during the interview, authorized persons should review the audio CD interview in its entirety. Rivera advised Your Affiant on 03/20/2021 he was an officiating judge for 'RIZE FC'. At the conclusion of the championship bout there was a gentleman trying to enter the cage. The promotor of the event was holding him back and the man was physically removed by security from the octagon. Rivera then talked about "... . group behind me that were very agitated . . . and then someone from table 6 threw a glass hookah over to the crows behind me and that's where mayhem occurred. Chairs began to be thrown, a big brawl was initiated, there was nowhere I could go, I was trapped right in the area I was in. So, I tried to exit the area and a Hispanic woman, black dress, black hair literally threw a chair at me - where I didn't have any involvement whatsoever. I stumbled back, I saw the husband of the woman smash another glass hookah on another gentleman. I grabbed the individual restrained him and tried to wait for authorities to come in and arrest the individual. Then I turned around and saw another older aged gentleman, in his midsixties, gray hair red shirt, with his hand up in the air and shot a firearm. Then the individual came to where I was and I did not realize it was the father, and how I know it was the father is because the gentleman I was restraining, notified me and yelled at me - that's my father I need to try and calm him down because he has a gun. And I looked, and the individual with the gun looked at me, I feared for me life then two individuals grabbed the gunman and escorted him out to the front. Again, I was thinking he was being arrested and come to find out he was let go in the front area of the venue."

Your Affiant confirmed with Rivera that he saw the Hispanic woman throw the chair at him to which he confirmed. When asked if he knows the woman, Rivera said he has never seen the woman before, but knows she was at table 6. He went on

stating the people at table 6 were disruptive the entire evening by yelling profanities, arguing with referees, throwing things, and causing disturbances.

Rivera sustained damage to his cornea with unknown damage to the internal eye area. Due to the proximity to his eye, doctors could not suture him, but instead glued the deep wound. He has severe headaches and is having difficulty sleeping. Rivera is no longer judging events due to the incident. He advised he was a paid judge.

Your Affiant asked if he had reviewed any video to which he confirmed. He advised he watched the video where the woman threw the chair at him. He then discussed the actions he previously advised. A copy of this interview was placed into PSBO Evidence.

Your Affiant positively identify the suspect's husband via 'Rize FC Sponsor Form' where Yasmani Hernandez provided his name, credit card number, billing address, and telephone number. Through investigative means the Hispanic woman standing next to him and with him throughout the melee was identified as Rosmery Estevez Hernandez, 11/02/1992, FL DL #E231-720-92-902-0. Cross-reference her DAVID photographs with provided social media confirmed she is 'rosylachulaa' on TikTok (https://www.tiktok.com/@rosylachulaa?lang=en) and _rosy_la_chula_ ANTONELLA on Instagram (https://www.instagram.com/ rosy_la_chula_/).





On 04/09/2021 at 0900hrs, Rivera responded to PBSO District 14 located at 120 North G Street, LWB, FL and was presented a photo lineup. Cpl. Fisher read the instructions aloud and had Rivera initial line and the bottom of the pamphlet indicating he understood. Cpl. Fisher left the area leaving Rivera to review the photo lineup alone. Rivera reviewed the photographs, choosing Estevez-Hernandez in position number 4 (four). Rivera circled the number 4 then dated and initialed under her photograph. This concluded the taped photo lineup presentation. Cpl. Fisher provided me a copy of the statement and the original lineup. Both were later placed in PBSO Evidence.

While Your Affiant was collecting paperwork from Cpl. Fisher, Rivera stated he is still having headaches for which he is seeing neurologist. His vision has not completely returned and he is afraid to return to MMA, which he has been involved with for over thirty-years.

Based on the aforementioned case facts, Your Affiant finds probable cause exists to charge Yasmani Hernandez Romero, 12/07/1989 with one (1) count of 'Inciting a Riot' per F.S.S. 870.01(2) to wit: did riot, or incite or encourage a riot by arguing with the MMA winners supporters, continuously putting himself in the face of the opposing MMA fighters supporters, smashing a glass hookah over a mans head, and trying to fight a member of the oppositions supporters (bald headed man); and one (1) count of 'Affray' per F.S.S. 870.01 to wit: did engage in an affray, contrary to Florida Statute 870.01.
